THE COUNTY HIGHWAY COMMITTEE FINDS AND DETERMINES THAT:

The proper establishing, laying out, widening, enlarging, extending, constructing, reconstructing, improving, or maintaining a portion of the highway now designated as County Trunk Highway "G", from a point

Beginning in the Town of Wingville at the South 1/4 corner of Section 22, Town 6 North, Range 1 West, and extending northerly, northwesterly, and northeasterly through Towns of Wingville, Castle Rock, and Muscoda, to a point 1320 feet east and 635 feet north of center of Section 15, Town 8 North, Range 1 West, Town of Muscoda,

and on roads or lands in and about and along and leading to same, requires certain relocation or change and the acquisition of lands or interests in lands as shown on the map or copy thereof marked,

"PLAT OF RIGHT OF WAY REQUIRED," for the Montfort - Muscoda Road, County Trunk Highway "G", Grant County, and

Pursuant to its authority under Section 83.08, Wisconsin Statutes,

THE COUNTY HIGHWAY COMMITTEE HEREBY ORDERS THAT:

(1) The said highway is hereby laid out and established to the lines and widths as shown on the said plat.

(2) The required lands or interests in lands as shown on the plat shall be acquired by the County Highway Committee of the county in which the lands are situated, pursuant to the provisions of Section 83.08, Wisconsin Statutes.

RELOCATION ORDER

BY GRANT COUNTY HIGHWAY COMMITTEE

GRANT COUNTY, WISCONSIN

THE GRANT COUNTY HIGHWAY COMMITTEE FINDS AND DETERMINES THAT:

The proper establishing, laying out, widening, enlarging, constructing, reconstructing, improving, or maintaining a portion of the highway now designated as County Trunk Highway "Q", from a point 1727 feet east, and 510 feet north of the southwest corner of Section 36, Township 7 North, Range 2 West.

Thence northeasterly to a point 630 feet north and 535 feet east of the center of said Section 36, Township 7 North, Range 2 West, and on roads or lands in and about and along and leading to same, requires certain relocation or change and the acquisition of lands or interests in lands as shown on the map or copy thereof marked

"PLAT OF RIGHT OF WAY REQUIRED, PROJECT S 0210(2)", for the Fennimore-Castle Rock Road, C.T.H. "Q", Grant County, dated AUGUST 8, 1957, the same being sheets No.s 3 AND 4 of the plans for said project, and

Pursuant to its authority under Section 83.08, Wisconsin Statutes,

THE GRANT COUNTY HIGHWAY COMMITTEE HEREBY ORDERS THAT:

(1) The said highway is hereby laid out and established to the lines and widths as shown on the said plat.

(2) The required lands or interests in lands as shown on the plat shall be acquired by the County Highway Committee of the county in which the lands are situate, pursuant to the provisions of Section 83.08, Wisconsin Statutes.

(3) This order supersedes and amends the previous order issued by the Committee on APRIL 11, 1957.
