The proper establishing, laying out, widening, enlarging, extending, constructing, reconstructing, improving or maintaining a portion of the highway now designated as County Trunk Highway "Q" from a point 2010 feet south and 2155 feet west of the northeast corner of Section 36, Township 7 North, Range 2 West, and extending thence northeasterly to a point 1030 feet north and 475 feet west of the south one-quarter corner of Section 28, Township 7 North, Range 1 West, and on roads or lands in and about and along and leading to same, requires certain relocation or change and the acquisition of lands or interests in lands as shown on the map or copy therefor marked,

"PLAT OF RIGHT OF WAY REQUIRED, PROJECT S 0210(4)," FENNIMORE-C.T.H. "G" ROAD, C.T.H. "Q", Grant County, dated July 14, 1958, the same being sheets no. 4, 4.1 and 4.2 of the plans for the said project, and

Pursuant to its authority under Section 83.08, Wisconsin Statutes,
