

RELOCATION ORDER

RELOCATION AND ACQUISITION OF RIGHT-OF-WAY  
On  
TOWN HIGHWAY, CHAFFIE HOLLOW ROAD

WHEREAS, the Town Board of Waterloo Township finds that proper establishment, laying out, construction, improving, and maintaining a 1,300.00 foot portion of Town Highway known as Chaffie Hollow Road and described as follows:

Beginning at a point 1,936.10 feet south and 2,441.63 feet west of the Northeast corner of Section 21, Township 3 North, Range 4 West, said point being located on the centerline of Chaffie Hollow Road at station 12+00.00; thence N 52°44'02" E, 65.53 feet to a point of curvature of a 1,909.86 foot radius curve to the right; thence along the arc of said curve 268.50 feet, whose long chord bears N 56°45'41" E, 268.28 feet to a point of tangency; thence N 60°47'20" E, 667.74 feet to a point of curvature of a 1,909.86 foot radius curve to the left; thence along the arc of said curve 158.33 feet, whose long curve bears N 58°24'50" E, 158.29 feet to a point of tangency; thence N 56°02'20" E, 139.90 feet to a point on the centerline of Chaffie Hollow Road at Station 25+00.00, said point being located 1,262.44 feet south and 1,331.40 feet west of the Northeast corner of Section 21:

AND WHEREAS, the Town Board of Waterloo Township finds that removing, obliterating, and vacating a 931.41 foot portion of Town Highway known as Chaffie Hollow Road, following construction of the new highway and bridge, and described as follows:

Beginning at a point 1,327.13 feet south of and 1,427.45 feet west of the Northeast corner of Section 21, Township 3 North, Range 4 West, said point being located on Chaffie Hollow Road at Station 24"TL"+31.41; thence S 41°04'33" W, 434.91 feet; thence S 76°49'02" W, 496.50 feet, to a point, said described line being located across a 50 foot pony truss and an adjoining 125 foot high steel truss bridge both of which are to be removed, said point being located on the centerline of Chaffie Hollow Road at Station 15"TL"+00.00, said point being located 1,768.21 feet south of and 2,186.63 feet west of the Northeast corner of Section 21;

requires certain relocation or changes and the acquisition of lands or interests in lands as shown on the attached plat marked "Plat of Right-of-Way required for Chaffie Hollow Road Bridge and Approaches", Town of Waterloo, Grant County, Project I.D. 5656-0-00 dated 6-9-81.
