For your convenience we are forwarding a copy of the authorization of access and plan page(s) recorded for the local roads at the Grant County Register of Deeds.

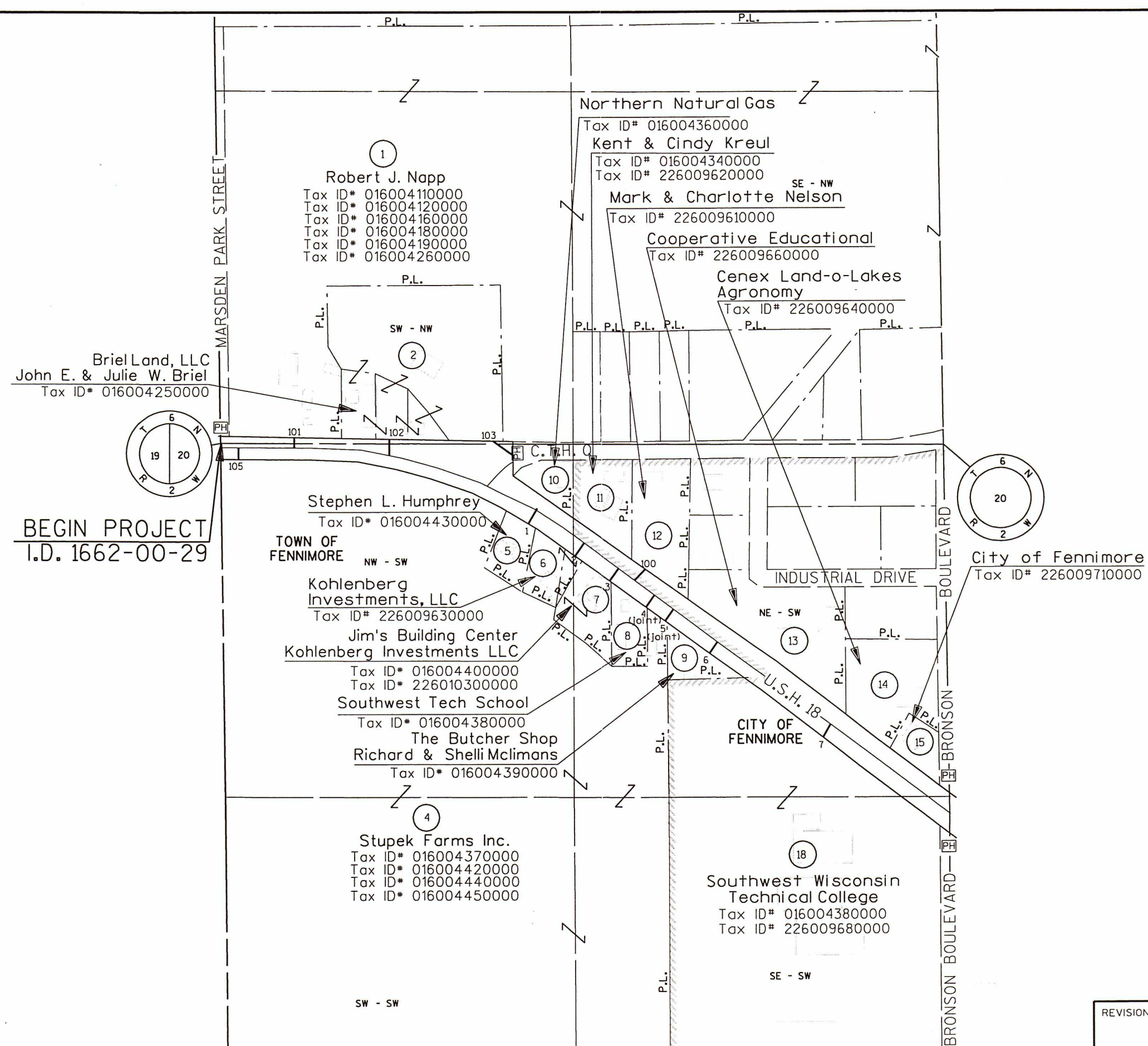
