

ORDER OF STATE HIGHWAY COMMISSION OF WISCONSIN TO COUNTY
TO CONVEY TITLE TO HIGHWAY RIGHT OF WAY TO STATE OF WISCONSIN

WHEREAS, the County Highway Committee of Grant County, Wisconsin, pursuant to order of the State Highway Commission dated October 11, 1945, acquired under Section 84.09(3), Statutes, or predecessor thereof, an easement for highway purposes in certain lands by conveyance dated March 25, 1946, from W. G. Rickok and Roxa, his wife, which was recorded with the Register of Deeds in Volume 2 of Highway Conveyances, on page 287, and

WHEREAS, the title to said land or interest in lands is transferable to the State of Wisconsin pursuant to Section 84.09(3)(b) on order of the Highway Commission to the County Clerk and the County Highway Committee,

IT IS HEREBY ORDERED that the said County Clerk and County Highway Committee of Grant County, Wisconsin, convey to the State of Wisconsin without charge the title or easement acquired in the following described lands, to wit:

A parcel of land in Township 4 North, Range 4 West, Sec. 8, S.E.1/4-S.E.1/4, Sec. 9, S.W.1/4-S.W.1/4 and in Sec. 16, N.W.1/4-N.W.1/4 thereof.

The reference line of new road is described as follows: Commencing at a point 660 ft. W. and 1130 ft. N. of center of Sec. 16, extending thence N. 59°-21' W. for 575 ft. to the point of a tangent curve, concave to the north having a radius of 2292 ft., thence northwesterly along the arc of said curve for 240 ft., to east line of N.W.1/4-N.W.1/4, and point of beginning, continuing thence northwesterly along the arc of said curve for 696.6 ft., thence N. 35°-56' W. for 373.8 ft. to the point of a tangent curve, concave to the west, with a radius of 1910 ft., extending thence northwesterly along arc of said curve for 1136.1 ft., thence N. 70°01' W. for 1142.5 ft.

The said parcel consists of all the land lying between northeasterly property limits of grantor and a new right of way line 50 ft. southwesterly of and parallel to above described new road reference line from point of beginning to a point 3349 ft. northwesterly along said reference line.

The area of said parcel, exclusive of land already in use for highway purposes, is 8.90 acres

The foregoing order was issued by the State Highway Commission of Wisconsin and entered in the minutes of its meeting on February 11, 1955.
