

RELOCATION ORDER
BY STATE HIGHWAY COMMISSION OF WISCONSIN

* * * * *

THE STATE HIGHWAY COMMISSION FINDS AND DETERMINES THAT:

The proper establishing, laying out, widening, enlarging, extending, constructing, reconstructing, improving, or maintaining a portion of the highway now designated as State Trunk Highway No. 35, from a point 205 feet north and 475 feet east of the west one-quarter corner of Section 25, Township 5 North, Range 5 West, thence southerly, southeasterly, and northeasterly to a point 105 feet east and 1120 feet south of northwest corner of Section 10, Township 4 North, Range 3 West,

and on roads or lands in and about and along and leading to same, requires certain relocation or change and the acquisition of lands or interests in lands as shown on the map or copy thereof marked

"PLAT OF RIGHT OF WAY REQUIRED, DIVISION JOB NO. 9486,"

for the Bloomington-Lancaster Road,

S.T. H. No. 35, Grant County, dated May 6, 1946,

the same being sheets Nos. 4, 5, 6, 7, 8, and 9 of the plans for said division job, and

Pursuant to its authority under Sections 84.02 (3) and 84.09, Wisconsin Statutes,

THE STATE HIGHWAY COMMISSION HEREBY ORDERS THAT:

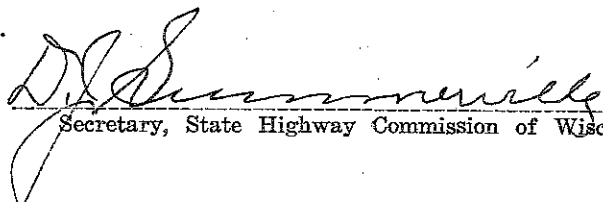
(1) The said highway is hereby laid out and established to the lines and widths as shown on the said plat.

(2) The required lands or interests in lands as shown on the plat shall be acquired by the County Highway Committee of the county in which the lands are situate, pursuant to the provisions of Section 84.09 (3), Wisconsin Statutes, except Parcels 1, 2, 3, 3A, 5, 6, 7, 8, 9, 10, 12, 13, 14, 15, 15A, 16, 17, 19, 20, 21, 22, 23, 24, 25, 26, 26A, 27, 28, 29, 30, 31, 32, 33, 33A, 34, 34A, 41, 42, 43, 44, 45, 52, 53, 54, 55, 55A, 56, 57, 58, and 59.

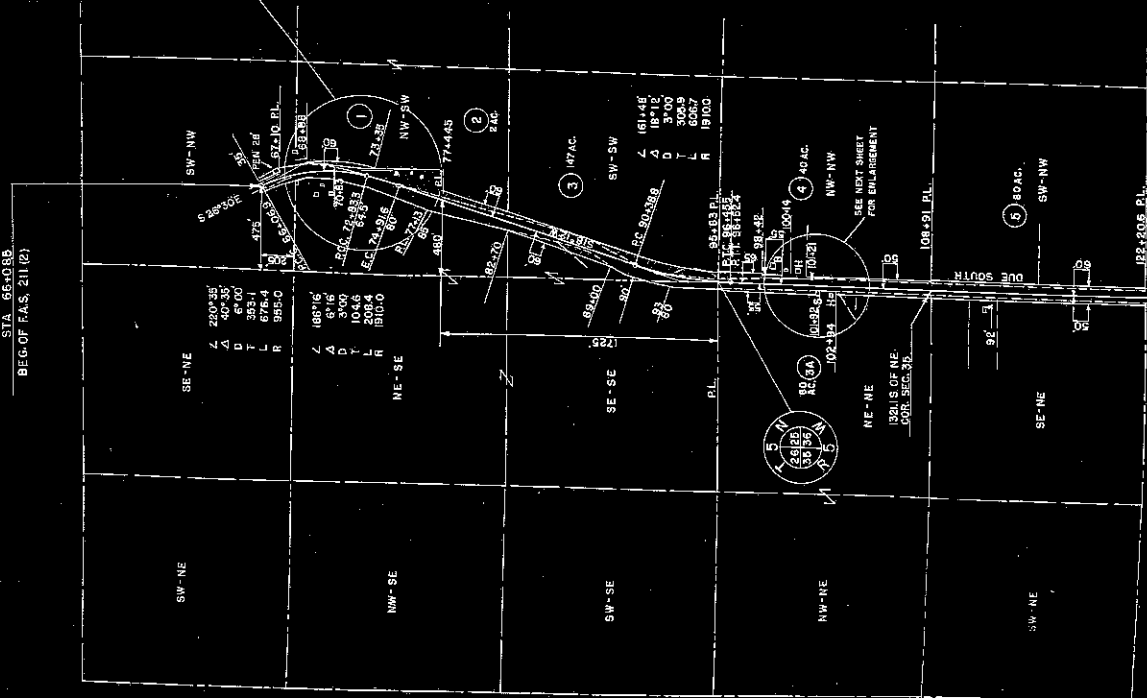
(3) This order supersedes and amends the previous order issued by the Commission on November 2, 1945.

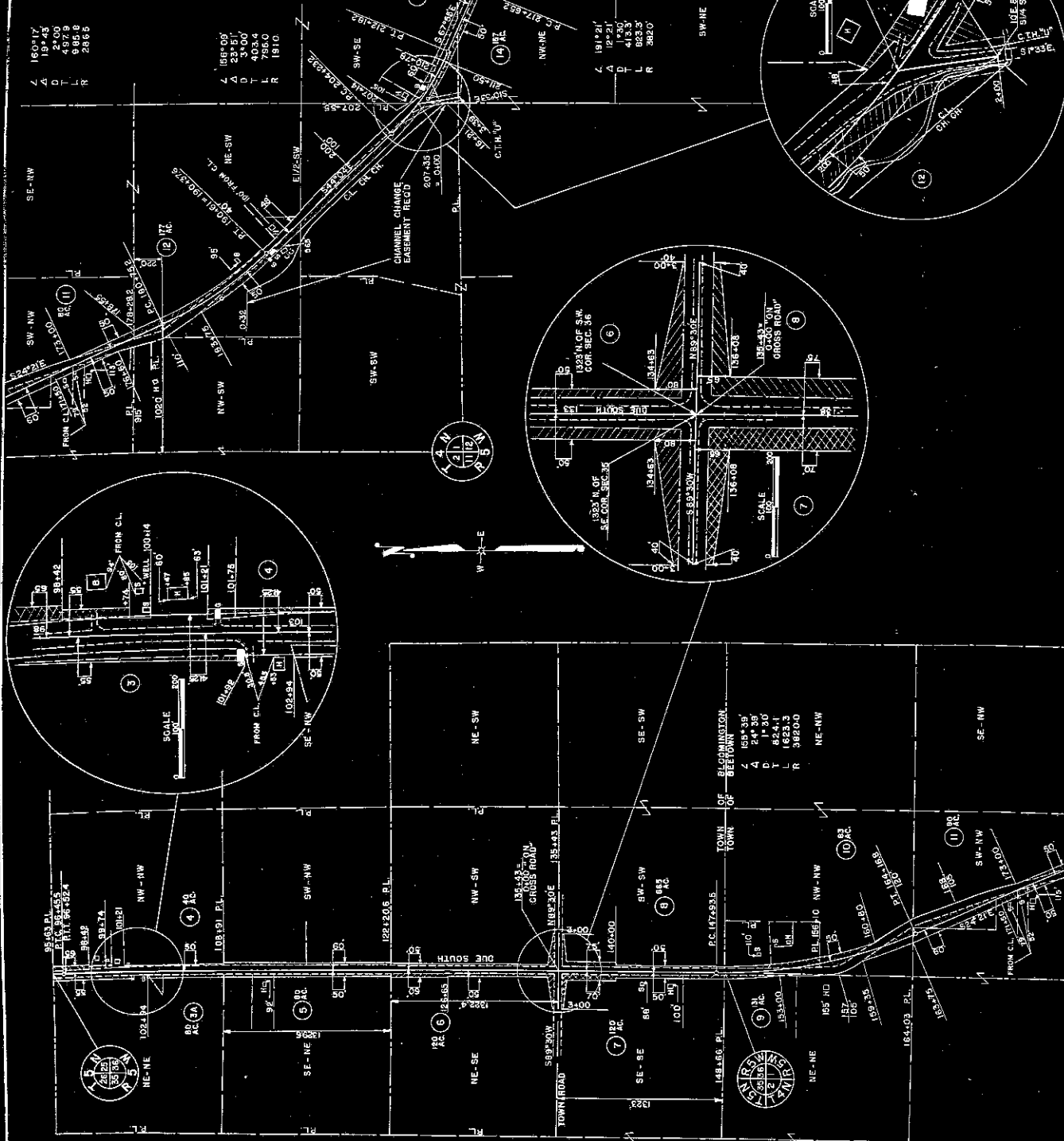

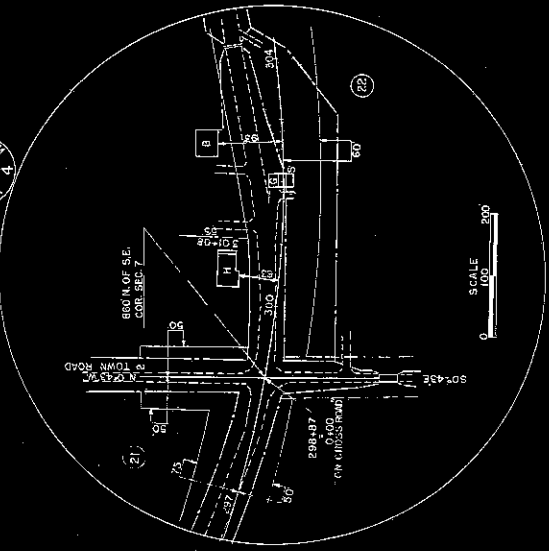

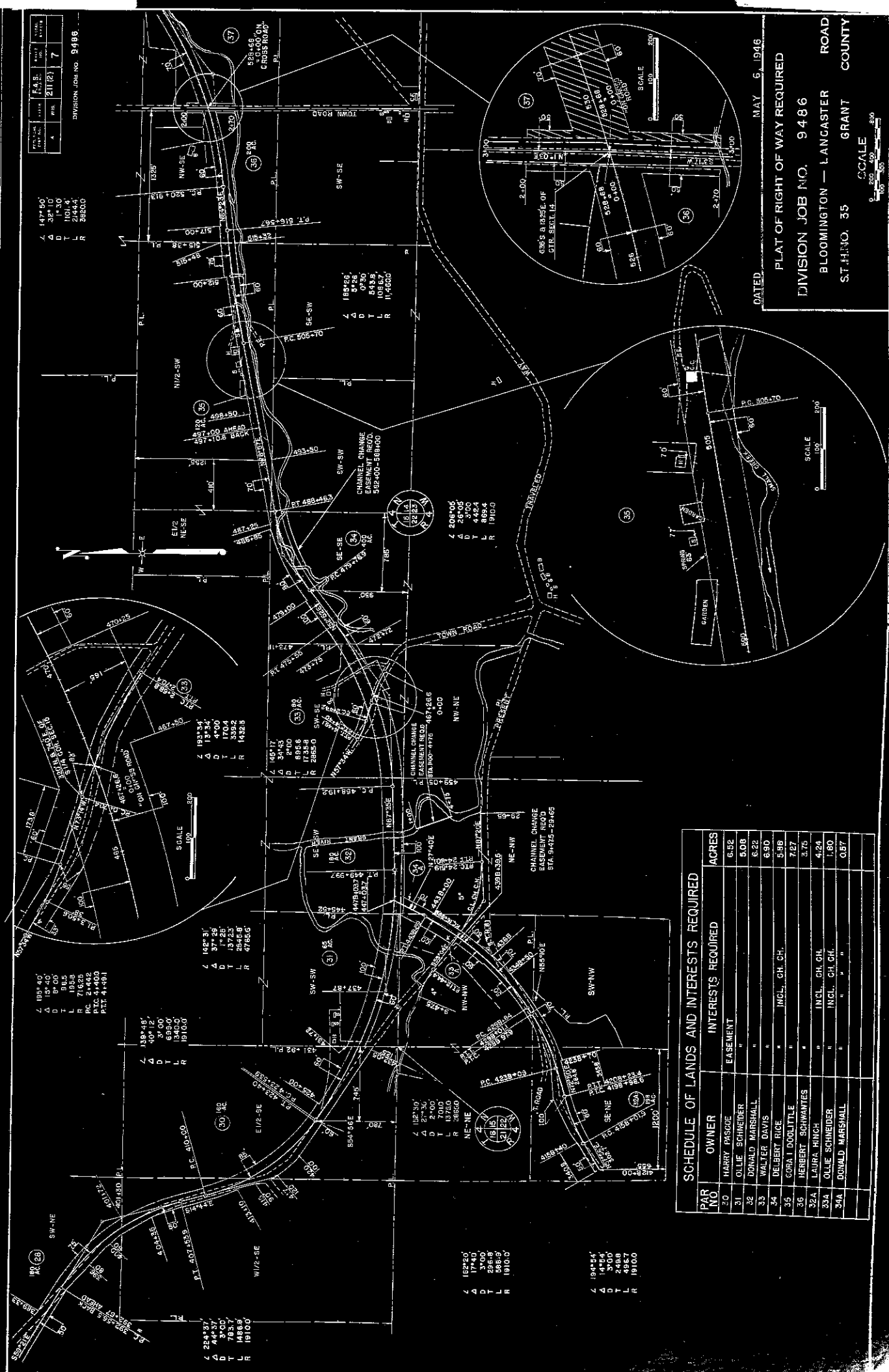
