BY STATE HIGHWAY COMMISSION OF WISCONSIN

THE STATE HIGHWAY COMMISSION FINDS AND DETERMINES THAT:

The proper establishing, laying out, widening, enlarging, extending, constructing, reconstructing, improv-
ing, or maintaining a portion of the highway now designated as U. S. Highway No. 18
from a point at the south one-quarter corner of Section 22, Township 6 North, Range 1 West,
and extending thence easterly to the center of Section 25, Township 6 North, Range 1 West,

and on roads or lands in and about and along and leading to same, requires certain relocation or change and
the acquisition of lands or interests in lands as shown on the map or copy thereof marked

"PLAT OF RIGHT OF WAY REQUIRED, ~~COMMISSION~~ Project F 017-1(22),"

for the Preston-Montfort Road,

U. S. H. No. 18, Grant County, dated April 3, 1947,

the same being sheet No. s. 4, 4.1 and 4.2 of the plans for said project,

Pursuant to its authority under Sections 84.02 (3) and 84.09, Wisconsin Statutes,

THE STATE HIGHWAY COMMISSION HEREBY ORDERS THAT:


(1) The said highway is hereby laid out and established to the lines and widths as shown on the said
plat.

(2) The required lands or interests in lands as shown on the plat shall be acquired by the County High-
way Committee of the county in which the lands are situate, pursuant to the provisions of Section 84.09 (3),
Wisconsin Statutes, except parcels 3, 4, 6, 7, and 8.

(3) This order supersedes and amends the previous order issued by the Commission on February 4, 1947.
