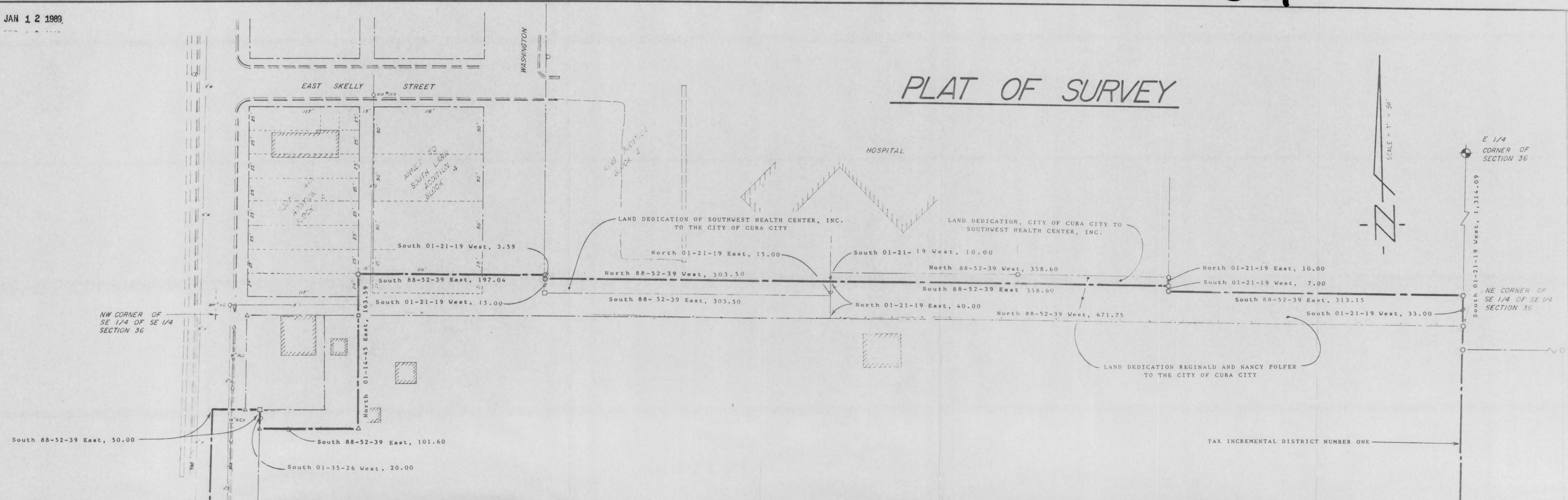
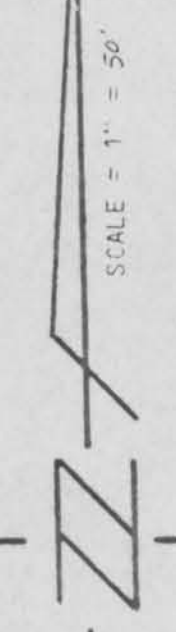

Commencing at the East 1/4 Corner of Section 36, T2N, R1W, Grant County, Wisconsin; thence South 01-21-19 West, 1,314.09 feet along the East line of the Southeast 1/4 of said Section 36 to the Southeast corner of the Northeast 1/4 of the Southeast 1/4 of said Section 36 to the point of beginning; thence North 88-52-39 West, 671.75 feet along the South line of the Northeast 1/4 of the Southeast 1/4 of said Section 36; thence North 01-21-19 East, 50.00 feet to a point on the East line of Block 3 of King's Addition to the City of Cuba City; thence South 88-52-39 East, 358.60 feet; thence South 01-21-19 West, 17.00 feet; thence South 88-52-39 East, 313.15 feet to the East line of the Southeast 1/4 of Section 36; thence South 01-21-19 West, 33.00 feet along said East line to the point of beginning;
