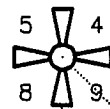

M., THE POINT OF BEGINNING OF THE TRACT HEREBY CONVEYED, THENCE WEST 100 FEET, THENCE NORTH 250 FEET, THENCE EAST 100 FEET, AND THENCE SOUTH 250 FEET TO THE PLACE OF BEGINNING.

THENCE N 00°26'29" E 79.52' ALONG THE WEST LINE OF SAID PROPERTY TO THE POINT OF BEGINNING;
THENCE N 00°26'29" E 170.48' ALONG SAID WEST LINE;
THENCE S 89°39'18" E 100.00' ALONG THE NORTH LINE OF SAID PROPERTY TO THE EAST LINE OF SAID SECTION 8;
THENCE N 00°26'29" E 97.00' ALONG SAID EAST LINE;
THENCE N 89°39'18" W 404.38'; THENCE S 00°26'29" W 160.00'; THENCE S 70°32'06" E 264.42'; THENCE SOUTHEASTERLY 58.24' ON THE ARC OF A CURVE CONCAVE SOUTHWESTERLY HAVING A RADIUS OF 888.11' AND A LONG CHORD WHICH BEARS S 68°39'22" E 58.23' TO THE POINT OF BEGINNING, CONTAINING 1.710 ACRES, MORE OR LESS, AND BEING SUBJECT TO ANY AND ALL EASEMENTS OF RECORD AND/OR USAGE.

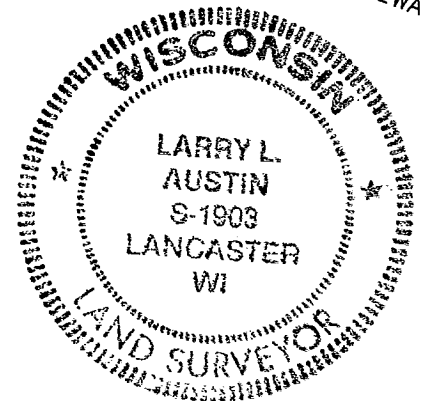
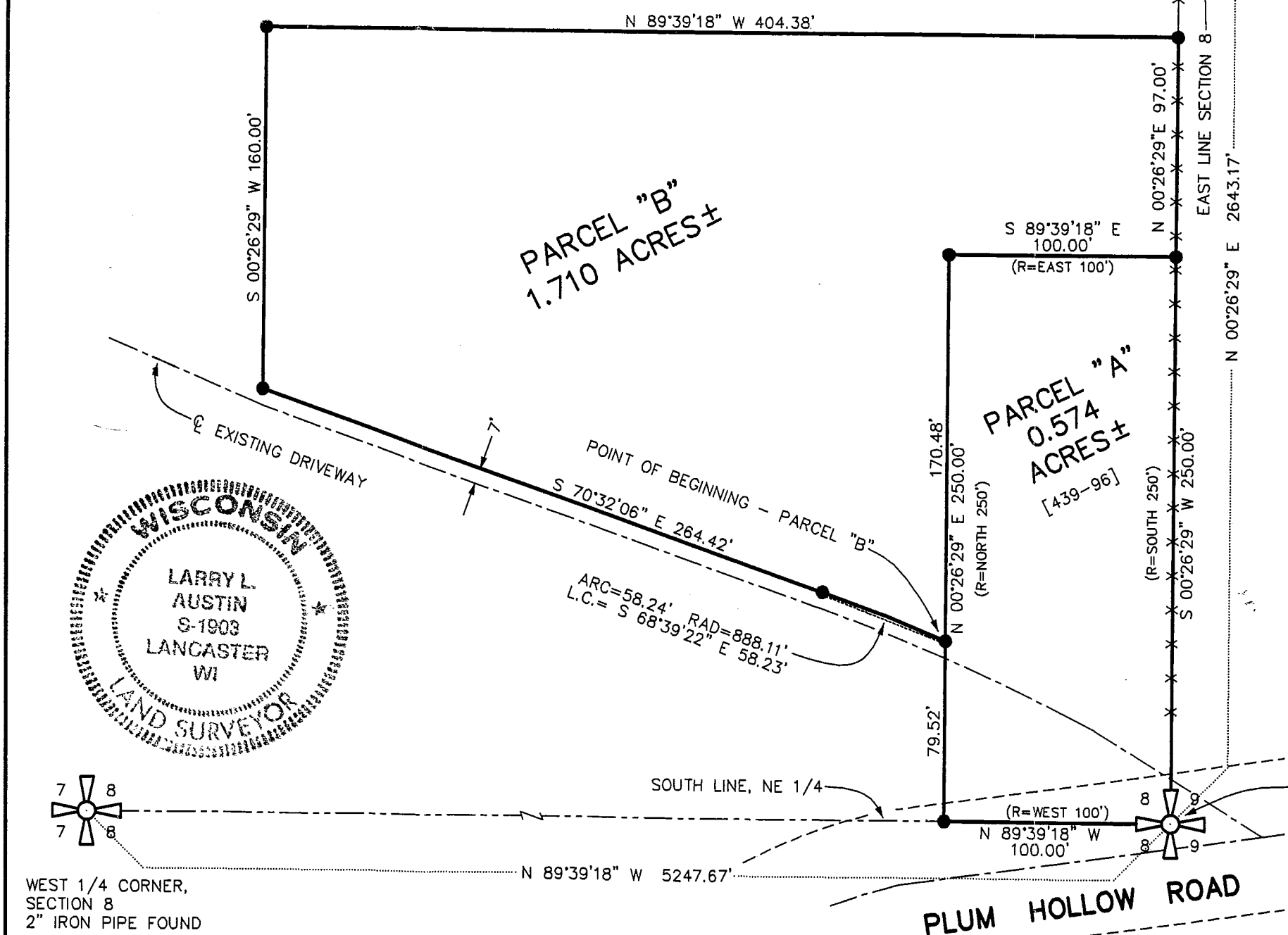
