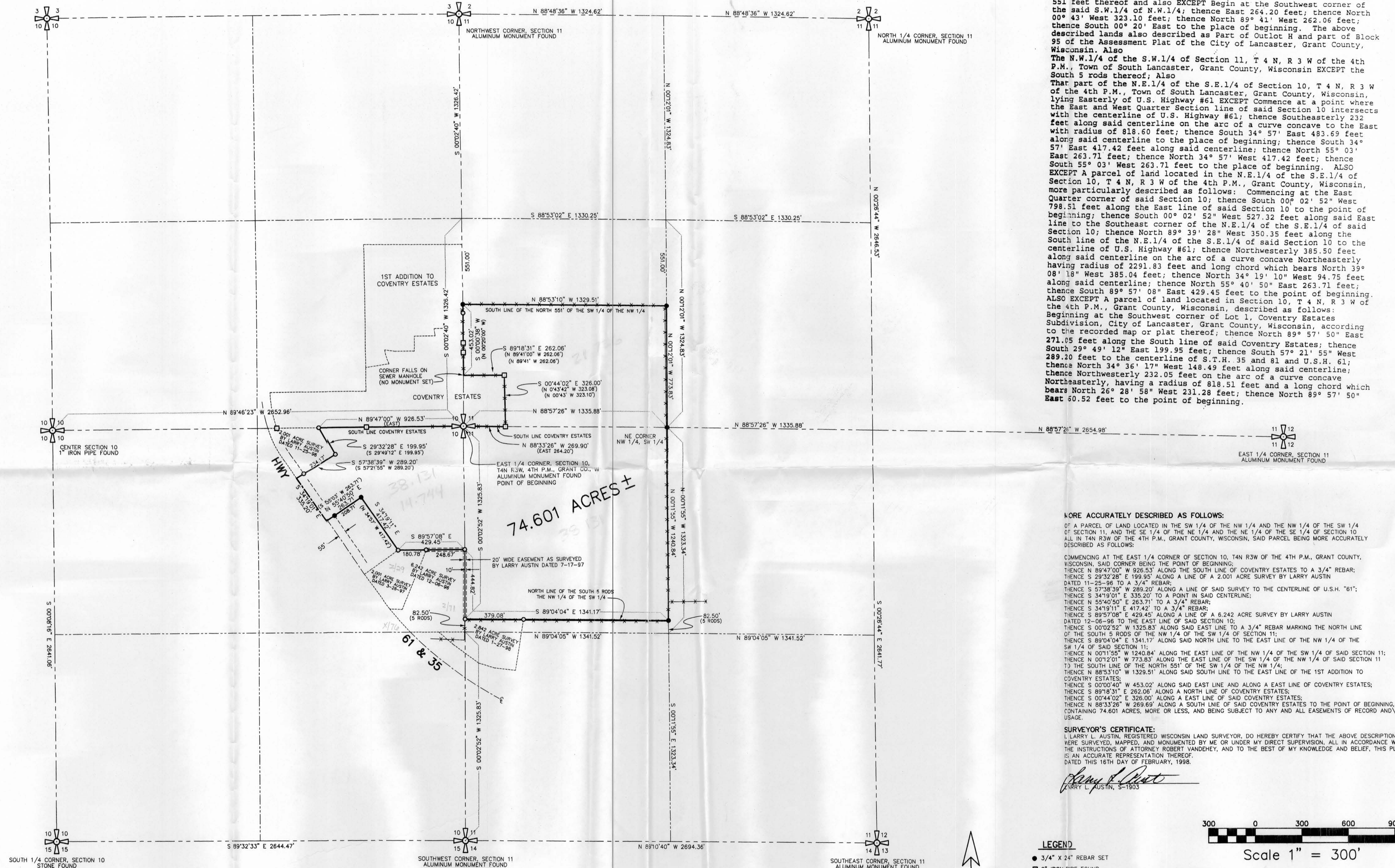


PLAT OF SURVEY FOR THE CITY OF LANCASTER ANNEXATION

DESCRIPTION PROVIDED:

1/92 1/92



The S.W.1/4 of the N.W.1/4 of Section 11, T 4 N, R 3 W of the 4th P.M., City of Lancaster, Grant County, Wisconsin, EXCEPT the North 551 feet thereof and also EXCEPT Begin at the Southwest corner of the said S.W.1/4 of N.W.1/4; thence East 264.20 feet; thence North 00° 43' West 323.10 feet; thence North 89° 41' West 262.06 feet; thence South 00° 20' East to the place of beginning. The above described lands also described as Part of Outlot H and part of Block 95 of the Assessment Plat of the City of Lancaster, Grant County, Wisconsin. Also

The N.W.1/4 of the S.W.1/4 of Section 11, T 4 N, R 3 W of the 4th P.M., Town of South Lancaster, Grant County, Wisconsin EXCEPT the South 5 rods thereof; Also

That part of the N.E.1/4 of the S.E.1/4 of Section 10, T 4 N, R 3 W of the 4th P.M., Town of South Lancaster, Grant County, Wisconsin, lying Easterly of U.S. Highway #61 EXCEPT Commence at a point where the East and West Quarter Section line of said Section 10 intersects with the centerline of U.S. Highway #61; thence Southeasterly 232 feet along said centerline on the arc of a curve concave to the East with radius of 818.60 feet; thence South 34° 57' East 493.69 feet along said centerline to the place of beginning; thence South 34° 57' East 417.42 feet along said centerline; thence North 55° 03' East 263.71 feet; thence North 34° 57' West 417.42 feet; thence South 55° 03' West 263.71 feet to the place of beginning. ALSO EXCEPT A parcel of land located in the N.E.1/4 of the S.E.1/4 of Section 10, T 4 N, R 3 W of the 4th P.M., Grant County, Wisconsin, more particularly described as follows: Commencing at the East Quarter corner of said Section 10; thence South 00° 02' 52" West 798.51 feet along the East line of said Section 10 to the point of beginning; thence South 00° 02' 52" West 527.32 feet along said East line to the Southeast corner of the N.E.1/4 of the S.E.1/4 of said Section 10; thence North 89° 39' 28" West 350.35 feet along the South line of the N.E.1/4 of the S.E.1/4 of said Section 10 to the centerline of U.S. Highway #61; thence Northwesterly 385.50 feet along said centerline on the arc of a curve concave Northeasterly having radius of 2291.83 feet and long chord which bears North 39° 08' 18" West 385.04 feet; thence North 55° 40' 50" East 263.71 feet; thence South 89° 57' 08" East 429.45 feet to the point of beginning. ALSO EXCEPT A parcel of land located in Section 10, T 4 N, R 3 W of the 4th P.M., Grant County, Wisconsin, described as follows: Beginning at the Southwest corner of Lot 1, Coventry Estates Subdivision, City of Lancaster, Grant County, Wisconsin, according to the recorded map or plat thereof; thence North 89° 57' 50" East 271.05 feet along the South line of said Coventry Estates; thence South 29° 49' 12" East 199.95 feet; thence South 57° 21' 55" West 289.20 feet to the centerline of S.T.H. 35 and 81 and U.S.H. 61; thence North 34° 36' 17" West 148.49 feet along said centerline; thence Northwesterly 232.05 feet on the arc of a curve concave Northeasterly, having a radius of 818.51 feet and a long chord which bears North 26° 28' 58" West 231.28 feet; thence North 89° 57' 50" East 60.52 feet to the point of beginning.

COMMENCING AT THE EAST 1/4 CORNER OF SECTION 10, T4N R3W OF THE 4TH P.M., GRANT COUNTY, WISCONSIN, SAID CORNER BEING THE POINT OF BEGINNING;

THENCE N 89°47'00" E 926.53' ALONG THE SOUTH LINE OF COVENTRY ESTATES TO A 3/4" REBAR;

THENCE S 29°32'28" E 199.95' ALONG A LINE OF A 2.001 ACRE SURVEY BY LARRY AUSTIN DATED 11-25-96 TO A 3/4" REBAR;

THENCE S 57°38'39" W 289.20' ALONG A LINE OF SAID SURVEY TO THE CENTERLINE OF U.S.H. "61";

THENCE S 34°19'01" E 335.20' TO A POINT IN SAID CENTERLINE;

THENCE N 55°40'50" E 263.71' TO A 3/4" REBAR;

THENCE S 34°19'11" E 417.42' TO A 3/4" REBAR;

THENCE S 89°57'08" E 429.45' ALONG A LINE OF A 6.242 ACRE SURVEY BY LARRY AUSTIN DATED 12-08-96 TO THE EAST LINE OF SAID SECTION 10;

THENCE S 00°02'52" W 1329.51' ALONG SAID EAST LINE TO A 3/4" REBAR MARKING THE NORTH LINE OF THE SOUTH 5 RODS OF THE NW 1/4 OF THE SW 1/4 OF SECTION 11;

THENCE S 89°04'04" E 1341.17' ALONG SAID NORTH LINE TO THE EAST LINE OF THE NW 1/4 OF THE SW 1/4 OF SAID SECTION 11;

THENCE N 00°11'55" W 1240.84' ALONG THE EAST LINE OF THE NW 1/4 OF SAID SECTION 11;

THENCE N 00°12'01" W 773.83' ALONG THE EAST LINE OF THE SW 1/4 OF THE NW 1/4 OF SAID SECTION 11 TO THE SOUTH LINE OF THE NORTH 551' OF THE SW 1/4 OF THE NW 1/4;

THENCE N 88°53'10" W 1329.51' ALONG SAID SOUTH LINE TO THE EAST LINE OF THE 1ST ADDITION TO COVENTRY ESTATES;

THENCE S 00°02'40" W 453.02' ALONG SAID EAST LINE AND ALONG A EAST LINE OF COVENTRY ESTATES;

THENCE S 89°18'31" E 262.06' ALONG A NORTH LINE OF COVENTRY ESTATES;

THENCE S 00°44'02" E 326.00' ALONG A EAST LINE OF SAID COVENTRY ESTATES;

THENCE N 88°33'26" W 269.69' ALONG A SOUTH LINE OF SAID COVENTRY ESTATES TO THE POINT OF BEGINNING, CONTAINING 74.601 ACRES, MORE OR LESS, AND BEING SUBJECT TO ANY AND ALL EASEMENTS OF RECORD AND/OR USAGE.

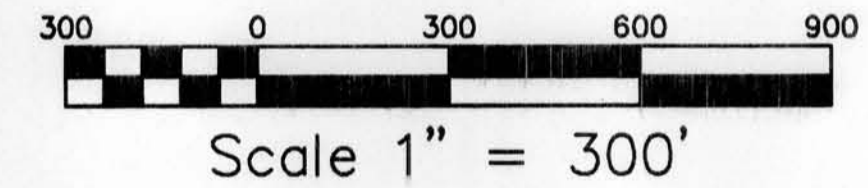
