PARCEL A
WOODED PARCEL

Commencing at the Southwest corner of Section 36, T4N R4W of the 4th P.M., Grant County, Wisconsin, said corner being the point of beginning;

THENCE N 00deg 15min 16sec W 1684.44 feet to a 3/4" iron bar on the West line of said Section;

THENCE S 76deg 56min 51sec E 589.81feet to a 3/4" iron bar;

THENCE S 05deg 48min 03sec W 1232.75 feet to a 3/4" iron bar;

THENCE N 87deg 32min 17sec W 181.08 feet to a 3/4" iron bar;

THENCE S 06deg 20min 40sec W 342.09 feet to the South line of said Section 36;

THENCE N 88deg 09min 44sec W 222.60 feet to the point of beginning, containing 16.976 acres, more or less, and being subject to any and all easements of record, including, but not limited to a ROW for Irish Hollow Road.

THENCE N 10deg 39min 40sec E 340.16 feet to a 3/4" iron bar;

THENCE N 87deg 46min 36sec W 434.05 feet to a 3/4" iron bar;

THENCE N 87deg 32min 17sec W 181.08 feet to a 3/4" iron bar;

THENCE S 06deg 20min 40sec W 342.09 feet to the point of beginning, containing 4.681 acres, more or less, and being subject to any and all easements of record, including, but not limited to a ROW for Irish Hollow Road and a 24 foot wide ingress-egress easement being described below.

PARCEL C
CROP GROUND PARCEL

Commencing at the Southwest corner of Section 36, T4N R4W of the 4th P.M., Grant County, Wisconsin; THENCE S 88deg 09min 44sec E 812.41 feet along the South line of said Section 36;

THENCE N 10deg 39min 40sec E 340.16 feet to a 3/4" iron bar marking the point of beginning;

THENCE N 26deg 19min 36sec E 821.28 feet to a 3/4" iron bar;

THENCE N 17deg 24min 42sec E 249.83 feet to a 3/4" iron bar at the Southeast corner of the Northwest 1/4 of the Southwest 1/4 of said Section 36;

THENCE N 00deg 18min 56sec W 1325.13 feet to a 3/4" iron bar at the Northeast corner of the Northwest 1/4 of the Southwest 1/4 of said Section 36;

THENCE N 87deg 52min 29sec W 1319.32 feet to the West 1/4 corner of said Section 36;

THENCE S 00deg 15min 16sec E 972.33 feet to a 3/4" iron bar on the West line of said Section 36;

THENCE S 87deg 46min 36sec E 434.05 feet to the point of beginning, containing 50.367 acres, more or less, and being subject to any and all easements of record, including, but not limited to a 24 foot wide ingress-egress easement being described below.

A 24 foot wide ingress-egress easement, being located Westerly of and adjacent to the following described reference line:


Commencing at the Southwest corner of Section 36, T4N R4W of the 4th P.M., Grant County, Wisconsin;
