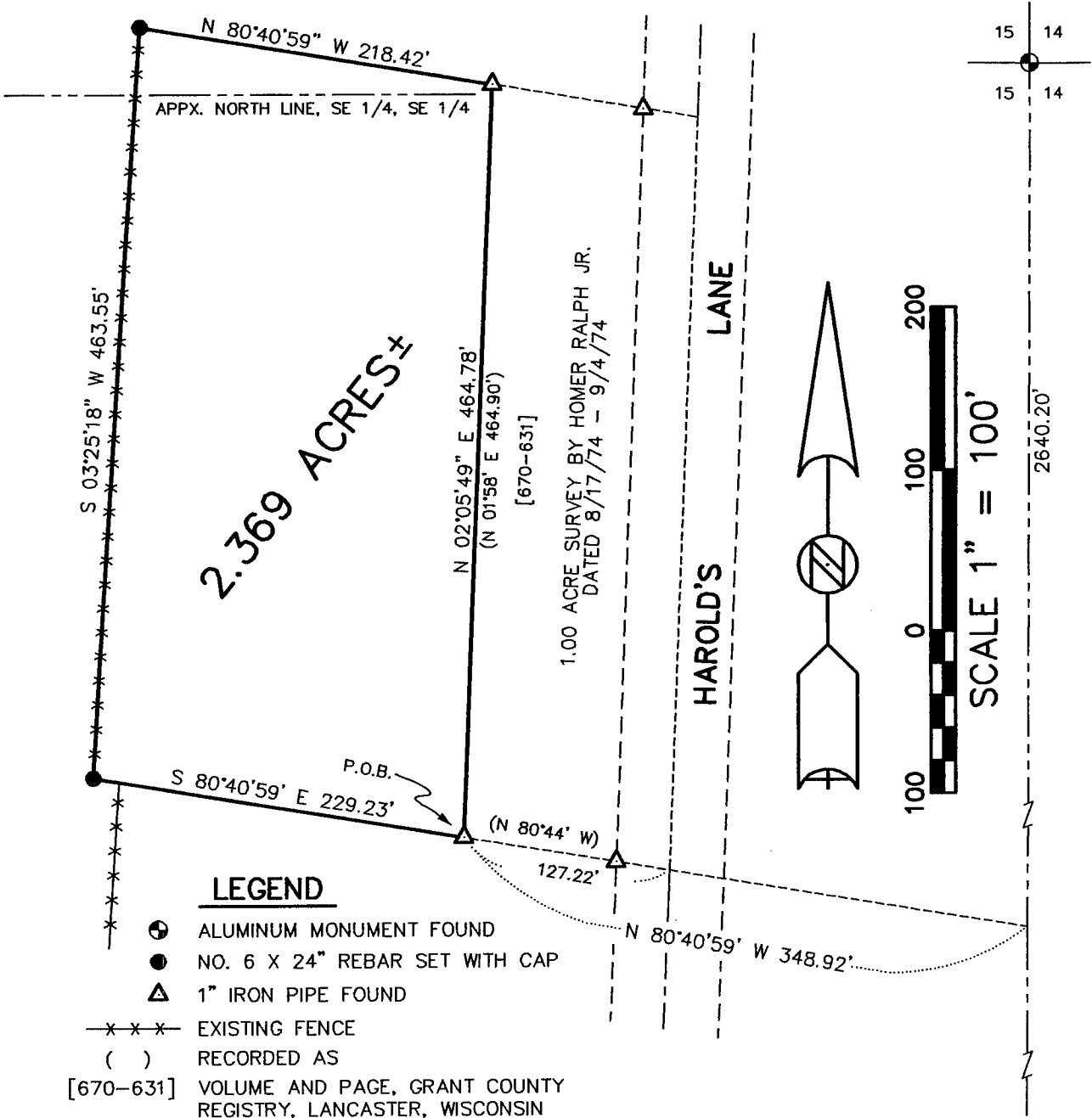


# PLAT OF SURVEY for DAVID KLAAS



### DESCRIPTION:

A PARCEL OF LAND LOCATED IN THE EAST 1/2 OF THE SOUTHEAST 1/4 OF SECTION 15, TOWN 5 NORTH, RANGE 2 WEST OF THE 4TH P.M., GRANT COUNTY, WISCONSIN, SAID PARCEL BEING DESCRIBED AS FOLLOWS:  
 COMMENCING AT THE SOUTHWEST CORNER OF SAID SECTION 15;  
 THENCE N 00°08'29" E 805.31' ALONG THE EAST LINE OF SAID SECTION 15;  
 THENCE N 80°40'59" W 348.92' TO A 1" IRON PIPE MARKING THE SOUTHWEST CORNER OF THAT PROPERTY AS DESCRIBED IN VOLUME 670, PAGE 631, GRANT COUNTY REGISTRY, SAID PIPE MARKING THE POINT OF BEGINNING;  
 THENCE N 02°05'49" E 464.78' ALONG THE WEST LINE OF SAID PROPERTY TO A 1" IRON PIPE MARKING THE NORTHWEST CORNER THEREOF;  
 THENCE N 80°40'59" W 218.42' TO A NO. 6 REBAR;  
 THENCE S 03°25'18" W 463.55' TO A NO. 6 REBAR;  
 THENCE S 80°40'59" E 229.23' TO THE POINT OF BEGINNING, CONTAINING 2.369 ACRES, MORE OR LESS, AND BEING SUBJECT TO ANY AND ALL EASEMENTS OF RECORD AND/OR USAGE.
