A parcel of land located in the Southeast 1/4 of the Southeast 1/4 of Section 13, Town 5 North, Range 1 West of the 4th P.M., Grant County, Wisconsin, said parcel being described as follows:

 Thence N 00°01'03" E 747.68' along the East line of said Section 13;
 Thence N 88°36'07" W 1016.82' along the North line of Woodward Avenue and it's extension thereof to the Westerly line of the right-of-way line of the old Chicago & Northwestern Railroad, and the point of beginning;
 Thence N 35°38'39" W 349.16' along said Westerly right-of-way line;
 Thence N 54°21'21" E 157.64';
 Thence S 35°25'48" E 319.69';
 Thence S 88°36'07" E 54.56' to the Easterly right-of-way line of the old Chicago & Northwestern Railroad;
 Thence S 30°42'13" E 139.02' to the extension of the North line of said Woodward Avenue;
 Thence N 88°36'07" W 235.57' along said Northerly extension to the point of beginning, containing 1.60 acres, more or less, and being subject to any and all easements of record and/or usage.

A parcel of land located in the Southeast 1/4 of the Southeast 1/4 of Section 13, Town 5 North, Range 1 West of the 4th P.M., Grant County, Wisconsin, said parcel being described as follows:

 Thence N 00°01'03" E 747.68' along the East line of said Section 13;
 Thence N 88°36'07" W 1016.82' along the North line of Woodward Avenue and it's extension thereof to the Westerly right-of-way line of the old Chicago & Northwestern Railroad;
 Thence N 35°38'39" W 349.16' along said Westerly right-of-way to the point of beginning;
 Thence N 54°21'21" E 157.64';
 Thence N 35°25'48" W 72.64' to the Southeast corner of a 1.043 acre survey by Matthew Janiak dated March 30, 1983;
 Thence S 54°21'21" W 157.91' along said survey to the Southwest corner thereof;
 Thence S 35°38'39" E 72.64' along the Westerly right-of-way line of the old Chicago & Northwestern Railroad to the point of beginning containing 0.26 acres, more or less, and being subject to any and all easements of record and/or usage.

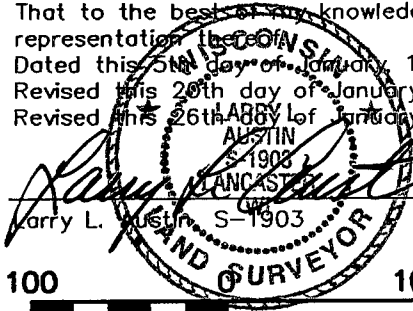
PARCEL "C"

 Thence N 88°36'07" W 15.00' along the extension of said Woodward Avenue;
 Thence N 30°42'13" W 139.02' to the Easterly right-of-way line of said Railroad;
 Thence S 35°38'39" E 147.54' along said Easterly right-of-way line to the point of beginning, containing 0.02 acre, more or less, and being subject to any and all easements of record and/or usage.
