PROPERTY DESCRIPTION:

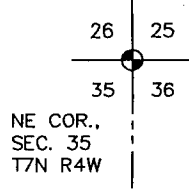
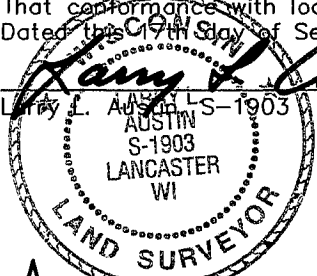
A parcel of land located in the Northeast 1/4 of Section 35, Town 7 North, Range 4 West of the 4th P.M., Grant County, Wisconsin, said parcel being described as follows: Commencing at a no. 6 rebar located 1494.18' South and 1257.72' West of the Northeast corner of said Section 35, said rebar marking the point of beginning; thence N 19°35'35" W 177.80' to a no. 6 rebar; Thence S 70°24'25" W 245.00' to a no. 6 rebar; Thence S 19°35'35" E 177.80' to a no. 6 rebar; Thence N 70°24'25" E 245.00' to the point of beginning, containing 1.000 acre, more or less, and being subject to any and all easements of record and/or usage.

A 33' WIDE INGRESS-EGRESS EASEMENT

A 33' wide ingress-egress easement, the centerline being described as follows: Commencing at the Northeast corner of Section 35, Town 7 North, Range 4 West of the 4th P.M., Grant County, Wisconsin; Thence S 00°11'57" E 950.00' along the East line of said Section 35; Thence N 89°55'15" W 834.37' along the South line of a 66.2453 acre survey by David Burbach dated 11/15/94 to the point of beginning; Thence S 16°28'15" W 58.77'; Thence S 28°04'19" W 118.20'; Thence S 22°18'49" W 241.84'; Thence S 17°11'17" W 156.37'; Thence S 01°48'41" E 83.20' Thence S 15°40'42" E 91.66'; Thence S 02°29'59" W 36.45'; Thence S 35°27'24" W 50.92'; Thence S 66°46'26" W 38.32'; Thence S 81°32'44" W 54.96'; Thence N 73°07'48" W 60.10'; Thence N 35°41'13" W 48.63'; Thence N 24°21'11" W 69.28'; Thence N 32°36'38" W 74.35'; Thence N 42°27'21" W 85.86' to the terminus point.

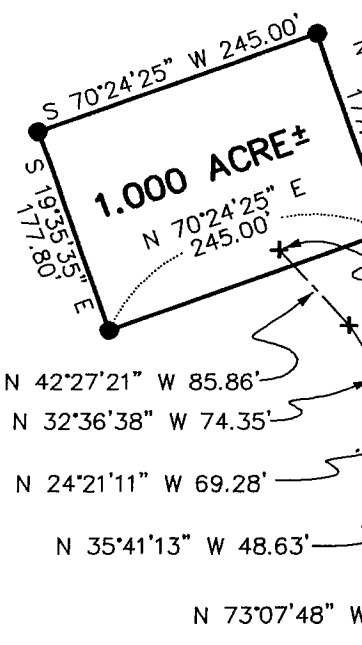
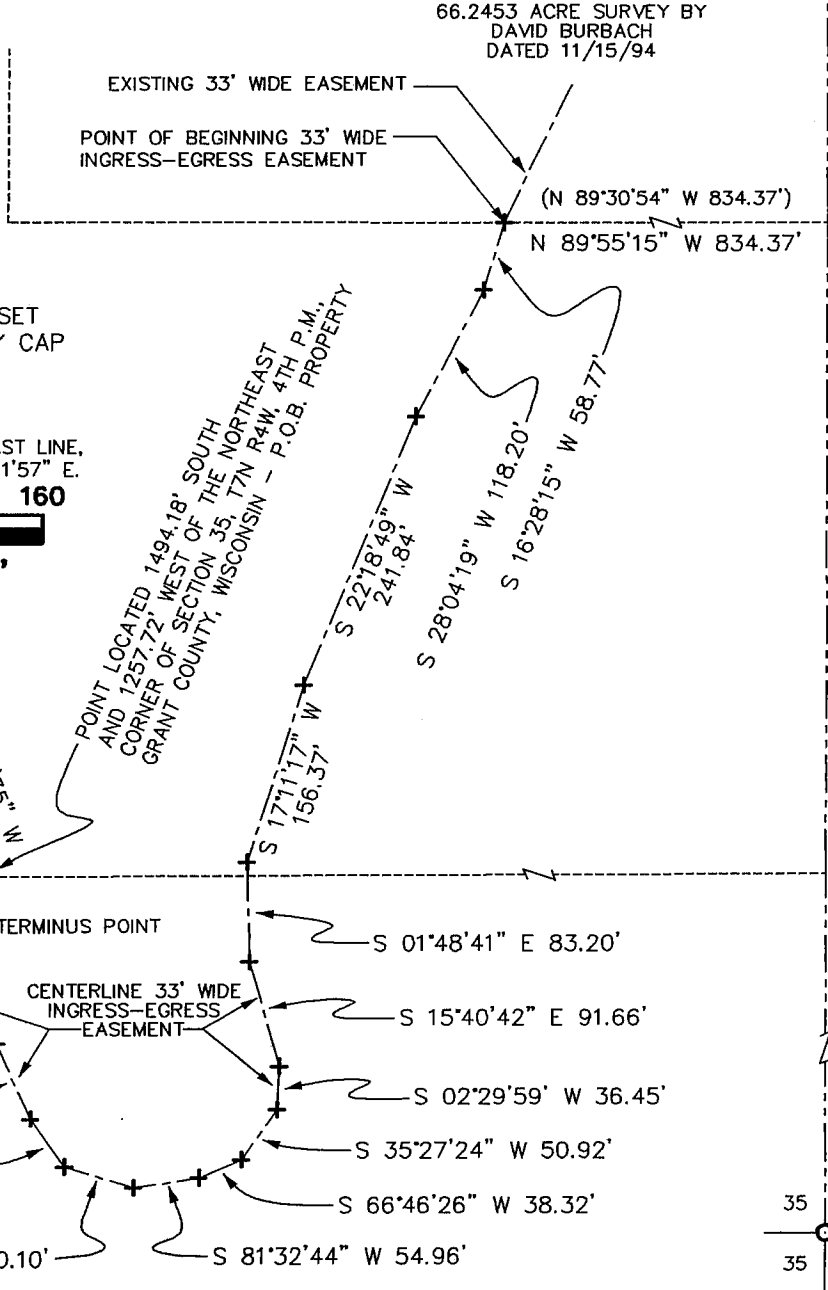
