The SW 1/4 of the SW 1/4, SE 1/4 of the SW 1/4, NE 1/4 of the SW 1/4, SW 1/4 of the SE 1/4 and parts of the NW 1/4 of the SW 1/4 and SE 1/4 of the SE 1/4 of Section 34, T8N, R1W, Muscoda Township, Grant County, Wisconsin, to wit:

Commencing at the S 1/4 CORNER of said Section 34; said point being the POINT OF BEGINNING; thence S 89° 53' 31" W, 2649.22' to the SW Corner of said Section 34; thence along the west line of the SW 1/4 of said Section 34; thence along the 1382.79'; thence N 42° 53' 15" E, 245.42'; thence N 1° 43' 24" W, 324.90'; thence N 72° 56' 07" E, 341.48'; thence N 0° 00' 56" E, 641.90' to the north line of the SW 1/4 of said Section 34; thence along said north line, N 89° 23' 31" E, 2153.39' to the NE Corner of said SW 1/4; thence along the east line of said SW 1/4, S 0° 15' 01" E, 1323.68' to the NW Corner of said SW 1/4 of the SE 1/4 of said Section 34; thence N 89° 13' 52" E, 2638.60' to the NE Corner of said SE 1/4 of the SE 1/4 of said Section 34; thence along the east line of the SE 1/4 of said Section 34, S 0° 33' 01" E, 689.25'; thence S 89° 04' 17" W, 694.98'; thence S 0° 33' 01" E, 627.00' to the south line of the SE 1/4 of Section 34; thence along said south line, S 89° 04' 17" W, 1950.59' to the POINT OF BEGINNING; said described parcel containing 220.60 acres, more or less.
