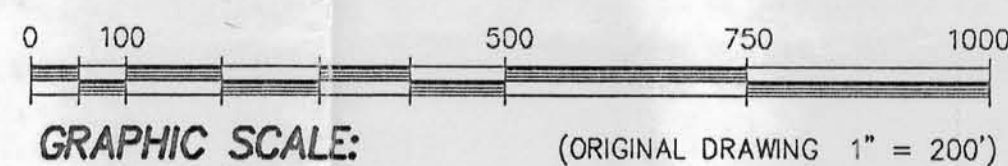

**DESCRIPTION:**

A parcel of land located in part of the SE 1/4 of the SE 1/4 of Section 13, T1N, R2W, Marion Township, and part of the fractional SW 1/4 of the NW 1/4 of Section 18 and part of the fractional NW 1/4 of the NW 1/4 of section 19, Hickory Grove Twp., T1N, R2W, all in Grant County, Wisconsin, to wit:

Commencing at the SE corner of said Section 13; thence West, 1285.46'; thence N 00°19'42" W, 275.16' to the Point of Beginning at a point in the centerline of Dry Hollow Road; thence continuing N 00°19'42" W, 380.92'; thence S 89°58'09" E, 644.18' to the c 1/32 of the SE 1/4 of the SE 1/4; thence N 44°24'12" E, 917.68'; thence S 89°45'50" E, 1374.90'; thence S 00°16'52" E, 1314.83'; thence S 00°23'47" E, 114.96'; thence N 89°32'20" W, 175.76'; thence N 05°25'07" W, 381.41'; thence N 75°08'09" W, 343.04'; thence N 77°51'35" W, 306.07'; thence S 84°25'39" W, 196.18'; thence N 89°19'47" W, 474.08'; thence S 74°21'51" W, 683.56'; thence S 70°22'34" W, 266.97' to a point in the centerline of Dry Hollow Road and point on a curve to the left, through a central angle of 08°24'45", an arc distance of 74.14', a radius of 500' and a chord bearing of N 48°08'30" W, 74.07' to a point in the same; thence N 52°23'22" W, 140.32' to the Point of Beginning.
