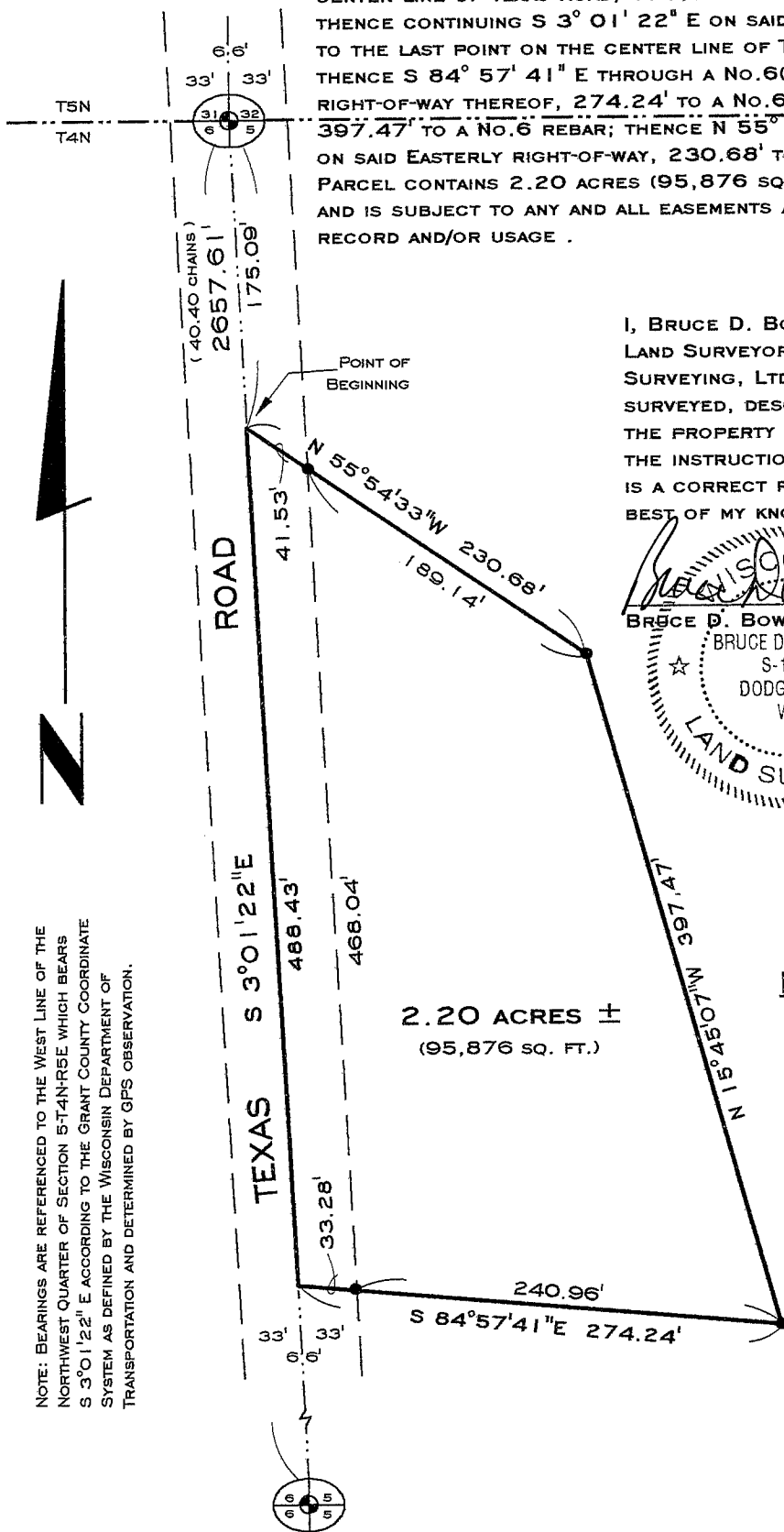


PLAT OF SURVEY FOR MARIAN AND ROBERT GRAF

TOWNSHIP, GRANT COUNTY, WISCONSIN.

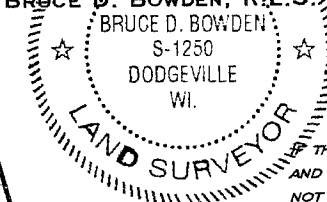
COMMENCING AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 5; THENCE S 3° 01' 22" E ON THE WEST LINE THEREOF, BEING THE CENTER LINE OF TEXAS ROAD, 175.09' TO THE POINT OF BEGINNING; THENCE CONTINUING S 3° 01' 22" E ON SAID WEST LINE, 488.43' TO THE LAST POINT ON THE CENTER LINE OF TEXAS ROAD; THENCE S 84° 57' 41" E THROUGH A No.6(3/4" DIA.) REBAR ON THE EASTERLY RIGHT-OF-WAY THEREOF, 274.24' TO A No.6 REBAR; THENCE N 15° 45' 07" W, 397.47' TO A No.6 REBAR; THENCE N 55° 54' 33" W THROUGH A No.6 REBAR ON SAID EASTERLY RIGHT-OF-WAY, 230.68' TO THE POINT OF BEGINNING. PARCEL CONTAINS 2.20 ACRES (95,876 SQUARE FEET), MORE OR LESS, AND IS SUBJECT TO ANY AND ALL EASEMENTS AND RIGHTS-OF-WAY OF RECORD AND/OR USAGE .



NOTE: BEARINGS ARE REFERENCED TO THE WEST LINE OF THE NORTHWEST QUARTER OF SECTION 5-T4N-R5E WHICH BEARS S 3° 01' 22" E ACCORDING TO THE GRANT COUNTY COORDINATE SYSTEM AS DEFINED BY THE WISCONSIN DEPARTMENT OF TRANSPORTATION AND DETERMINED BY GPS OBSERVATION.

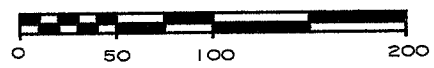
