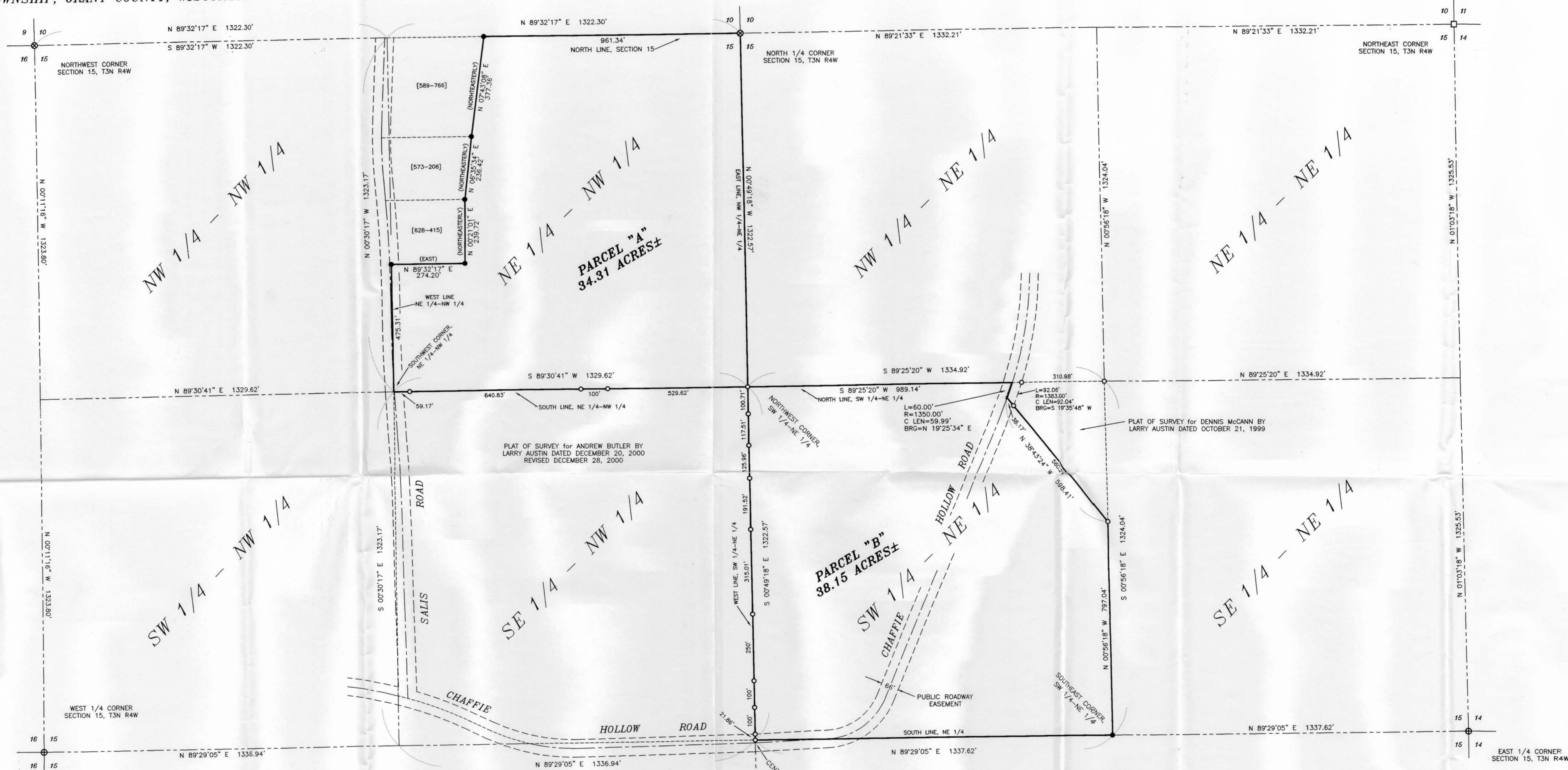


# PLAT OF SURVEY for DALE MEIER

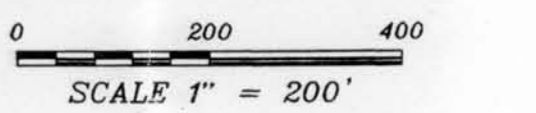
**DESCRIPTION OF PARCEL "A":**  
 The Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4) of Section Fifteen (15), Town Three (3) North, Range Four (4) West of the 4th P.M., Grant County, Wisconsin, EXCEPTING THEREFROM that property as described in Volume 589, Page 766, Grant County Registry;  
 EXCEPTING THEREFROM that property as described in Volume 573, Page 208, Grant County Registry;  
 EXCEPTING THEREFROM that property as described in Volume 626, Page 415, Grant County Registry.

**DESCRIPTION OF PARCEL "B":**  
 The Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of Section Fifteen (15), Town Three (3) North, Range Four (4) West of the 4th P.M., Grant County, Wisconsin, EXCEPTING THEREFROM the following described parcel:  
 Begin at the NE corner of the SW 1/4 of the NE 1/4 of Section 15, T 3 N, R 4 W of the 4th P.M. in Grant County, Wisconsin, thence S 527', thence northwesterly to a point in the centerline of Chaffie Hollow Road which is 60' southerly from a point formed by the intersection of said centerline with the North line of said SW 1/4 of said NE 1/4, thence Northerly 60' to said point of intersection, thence E on said North line to the place of beginning.
