

PLAT OF SURVEY for ROBERT SHIELDS

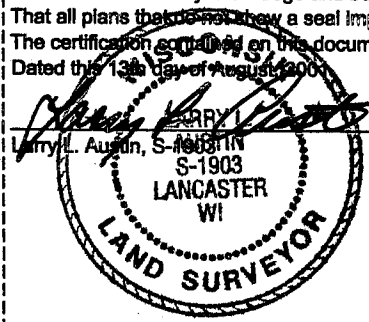
LOCATED IN LOTS NUMBER TWO (2) AND SEVEN (7) IN BLOCK NUMBER SIX (6),

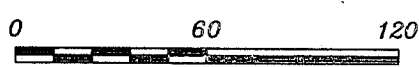
