


PLAT OF SURVEY for ROGER SEDGWICK

Commencing at the Northeast corner of said Section;


Thence South 00° 50' 35" West 537.76' along the East line of said Section; Thence South 75° 04' 02" West 427.20' the point of beginning; Thence South 75° 04' 02" West 164.09'; Thence South 10° 56' 01" East 118.85'; Thence North 85° 24' 25" East 170.40'; Thence North 13° 06' 46" West 149.22' to the point of beginning.


