

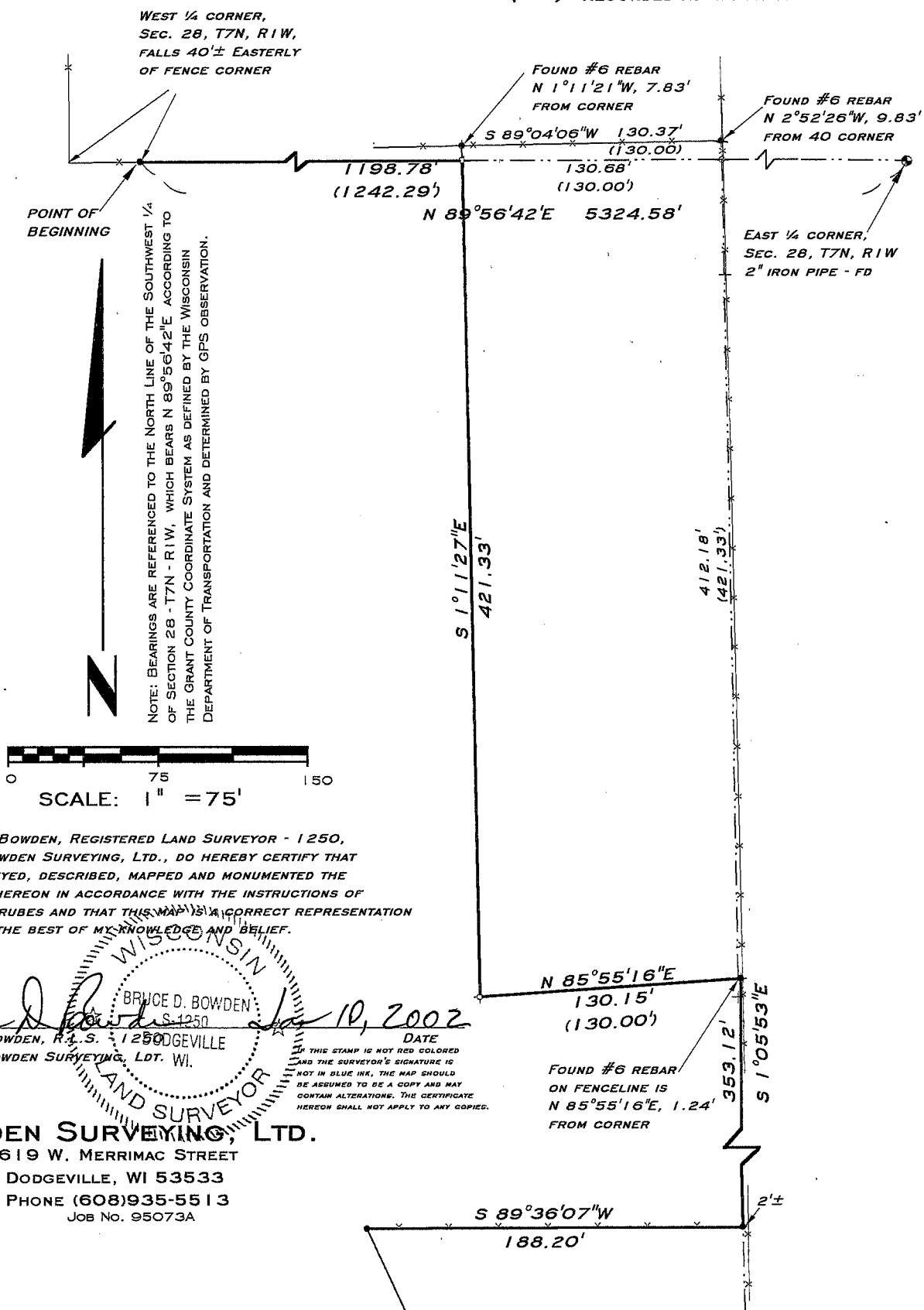
PLAT OF SURVEY FOR LARRY HRUBES

A LINE LOCATED IN THE NORTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 28, TOWN 7 NORTH, RANGE 1 WEST, CASTLE ROCK TOWNSHIP, GRANT COUNTY, WISCONSIN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE WEST 1/4 CORNER OF SECTION 28; THENCE N 89°56'42"E, 1198.78' ALONG THE NORTH LINE OF THE SOUTHWEST QUARTER TO A No. 6 (3/4" DIA. X 24") REBAR SET THIS SURVEY; THENCE S 1°11'27"E, 421.33' TO A No. 6 REBAR SET THIS SURVEY; THENCE N 85°55'16"E, 130.15' TO THE EAST LINE OF THE SOUTHWEST QUARTER; THENCE S 1°05'53"E, 353.12' ALONG SAID EAST LINE TO A No. 6 REBAR; THENCE S 89°36'07"W, 188.20' TO A No. 6 REBAR AND THE TERMINATION OF THE LINE BEING DESCRIBED HEREIN.

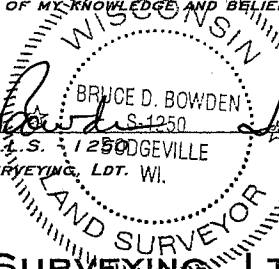
