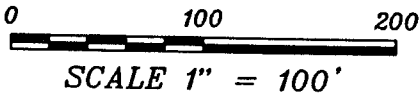


# PLAT OF SURVEY for MONICA BARTELS

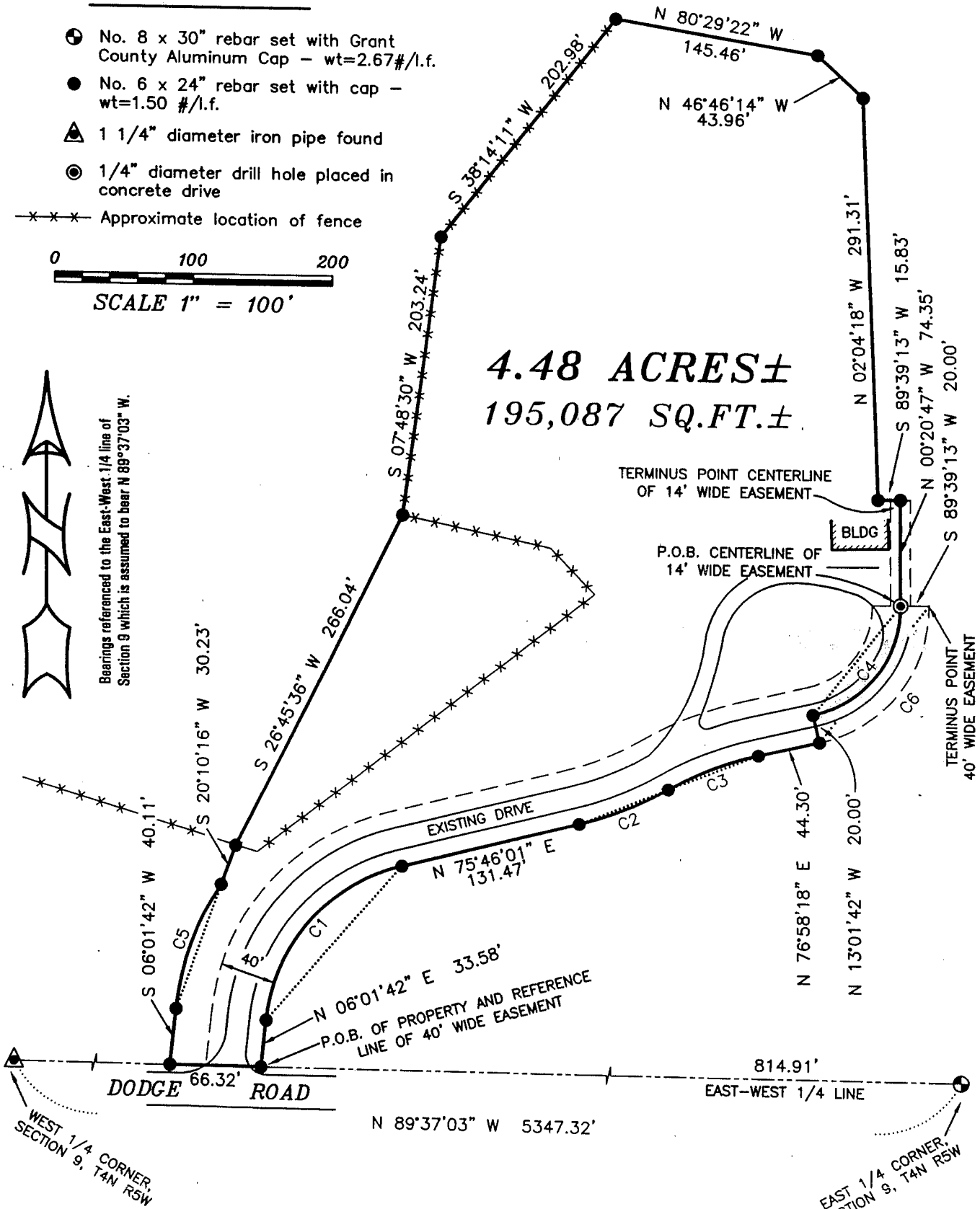
## LEGEND

- x-x-x- Approximate location of fence

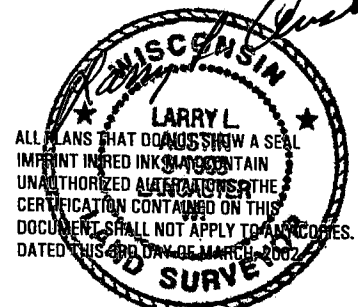


Bearings referenced to the East-West 1/4 line of Section 9 which is assumed to bear N 89°37'03" W.

## PROPERTY DESCRIPTION:


Part of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section Nine (9), Town Four (4) North, Range Five (5) West of the 4th P.M., Grant County, Wisconsin, containing 4.48 acres, more or less, and being described as follows:  
Commencing at the East Quarter (E 1/4) corner of said Section;  
thence North 89° 37' 03" West 814.91' along the East-West Quarter (E-W 1/4) line of said Section to the point of beginning;  
thence North 06° 01' 42" East 33.58' to a No. 6 rebar;  
thence 158.23' on the arc of a curve to the right having a radius of 130.00' and a long chord bearing North 40° 53' 52" East 148.64' to a No. 6 rebar;  
thence North 75° 46' 01" East 131.47' to a No. 6 rebar;  
thence 69.11' on the arc of a curve to the left having a radius of 247.20' and a long chord bearing North 67° 45' 30" East 68.88' to a No. 6 rebar;  
thence 69.13' on the arc of a curve to the right having a radius of 230.00' and a long chord bearing North 68° 21' 38" East 68.87' to a No. 6 rebar;  
thence North 76° 58' 18" East 44.30' to a No. 6 rebar;  
thence North 13° 01' 42" West 20.00' to a No. 6 rebar;  
thence 107.97' on the arc of a curve to the left having a radius of 80.00' and a long chord bearing North 38° 18' 45" East 99.95' to a 1/4" diameter drill hole in concrete;  
thence North 00° 20' 47" West 74.35' to a No. 6 rebar;  
thence South 89° 39' 13" West 15.83' to a No. 6 rebar;  
thence North 02° 04' 18" West 291.31' to a No. 6 rebar;  
thence North 46° 46' 14" West 43.96' to a No. 6 rebar;  
thence North 80° 29' 22" West 145.46' to a No. 6 rebar;  
thence South 38° 14' 11" West 202.98' to a No. 6 rebar;  
thence South 07° 48' 30" West 203.24' to a No. 6 rebar;  
thence South 26° 45' 36" West 266.04' to a No. 6 rebar;  
thence South 20° 10' 16" West 30.23' to a No. 6 rebar;  
thence 96.76' on the arc of a curve to the left having a radius of 196.00' and a long chord bearing South 20° 10' 16" West 95.78' to a No. 6 rebar;  
thence South 06° 01' 42" West 40.11' to the East-West Quarter (E-W 1/4) line of said Section;  
thence South 89° 37' 03" East 66.32' along said East-West Quarter (E-W 1/4) line to the point of beginning.  
Parcel being subject to any and all easements of record.

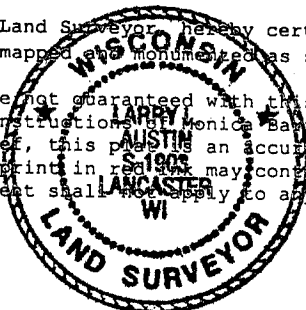
## EASEMENT DESCRIPTION:

An ingress-egress easement being located in part of the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section Nine (9), Town Four (4) North, Range Five (5) West of the 4th P.M., Grant County, Wisconsin, and being described as follows:  
A Forty foot (40') wide ingress-egress easement being located Westerly and Northerly of the following described line:  
Commencing at the East Quarter (E 1/4) corner of said Section;  
thence North 89° 37' 03" West 814.91' along the East-West Quarter (E-W 1/4) line of said Section to the point of beginning;  
thence North 06° 01' 42" East 33.58' to a No. 6 rebar;  
thence 158.23' on the arc of a curve to the right having a radius of 130.00' and a long chord bearing North 40° 53' 52" East 148.64' to a No. 6 rebar;  
thence North 75° 46' 01" East 131.47' to a No. 6 rebar;  
thence 69.11' on the arc of a curve to the left having a radius of 247.20' and a long chord bearing North 67° 45' 30" East 68.88' to a No. 6 rebar;  
thence 69.13' on the arc of a curve to the right having a radius of 230.00' and a long chord bearing North 68° 21' 38" East 68.87' to a No. 6 rebar;  
thence North 76° 58' 18" East 44.30' to a No. 6 rebar;  
thence 134.95' on the arc of a curve to the left having a radius of 100.00' and a long chord bearing North 38° 18' 45" East 124.94' to the terminus point of the 40' wide easement;  
thence South 89° 39' 13" West 20.00' to the point of beginning of a Fourteen foot (14') wide easement, the centerline being described as follows:  
thence North 00° 20' 47" West 74.35' to the terminus point.
