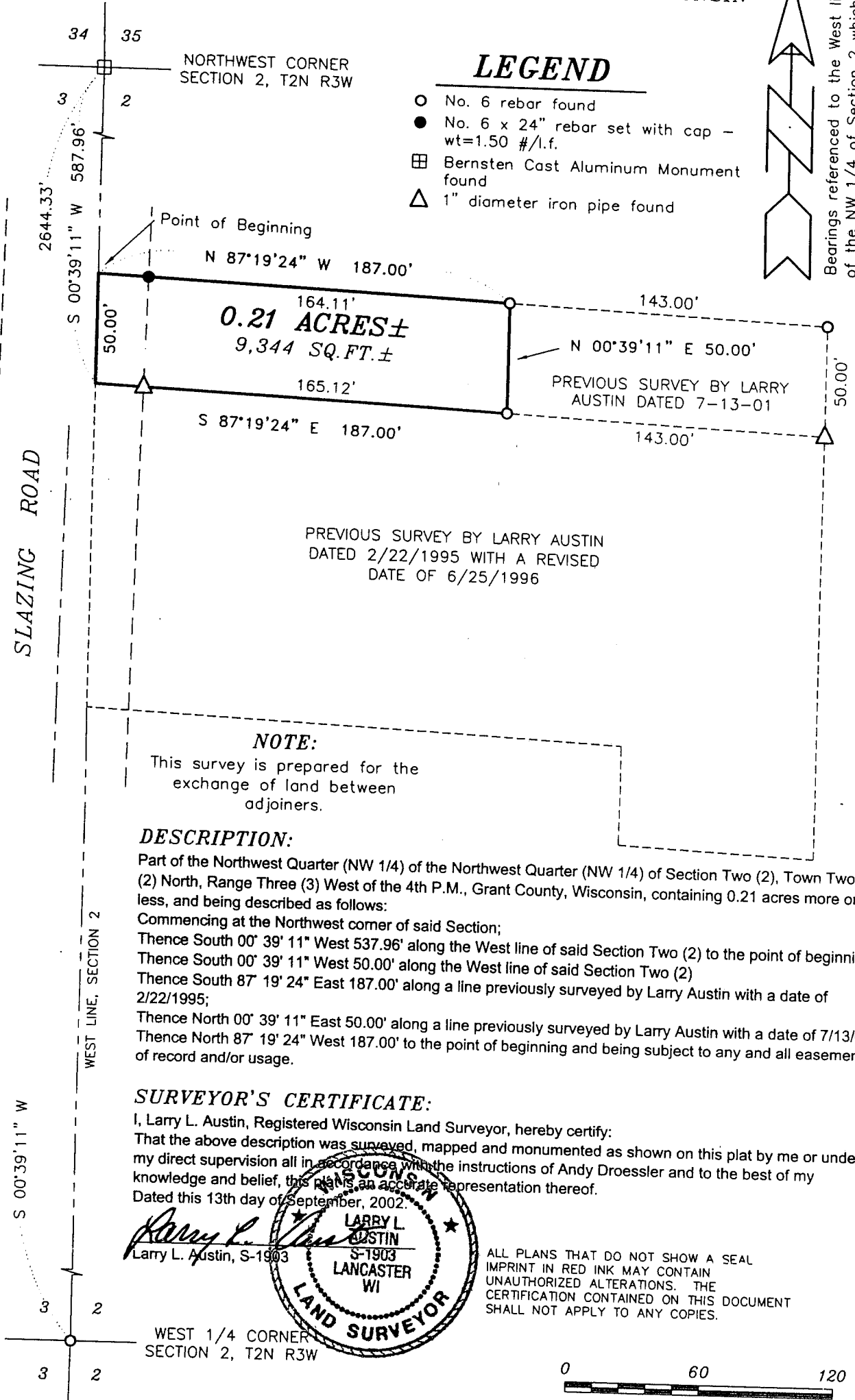


## PLAT OF SURVEY for ANDY DROESSLER

Commencing at the Northwest corner of said Section;  
Thence South 00° 39' 11" West 537.96' along the West line of said Section Two (2) to the point of beginning;  
Thence South 00° 39' 11" West 50.00' along the West line of said Section Two (2)  
Thence South 87° 19' 24" East 187.00' along a line previously surveyed by Larry Austin with a date of 2/22/1995;  
Thence North 00° 39' 11" East 50.00' along a line previously surveyed by Larry Austin with a date of 7/13/01;  
Thence North 87° 19' 24" West 187.00' to the point of beginning and being subject to any and all easements of record and/or usage.

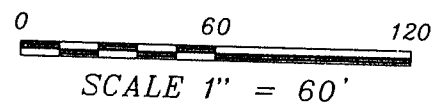
