TRACT 1 DESCRIPTION:

Part of the Northeast Quarter (NE 1/4) of the Northwest Quarter (NW 1/4), the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4), the Southeast Quarter (SE 1/4) of the Northwest Quarter (NW 1/4) and the Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) of Section Thirty (30), Town Six (6) North, Range Three (3) West of the 4th P.M., Mount Ida Township, Grant County, Wisconsin, containing 157.77 acres, more or less, and being described as follows:

Commencing at the West Quarter (W 1/4) corner of said Section Thirty (30), said corner being the point of beginning;
thence North 00° 17' 59" East 1320.31' to the Northwest corner of the Southwest Quarter (SW 1/4) of said Northwest Quarter (NW 1/4);
thence South 89° 21' 33" East 1361.01' to the Northeast corner of the Southwest Quarter (SW 1/4) of said Northwest Quarter (NW 1/4);
