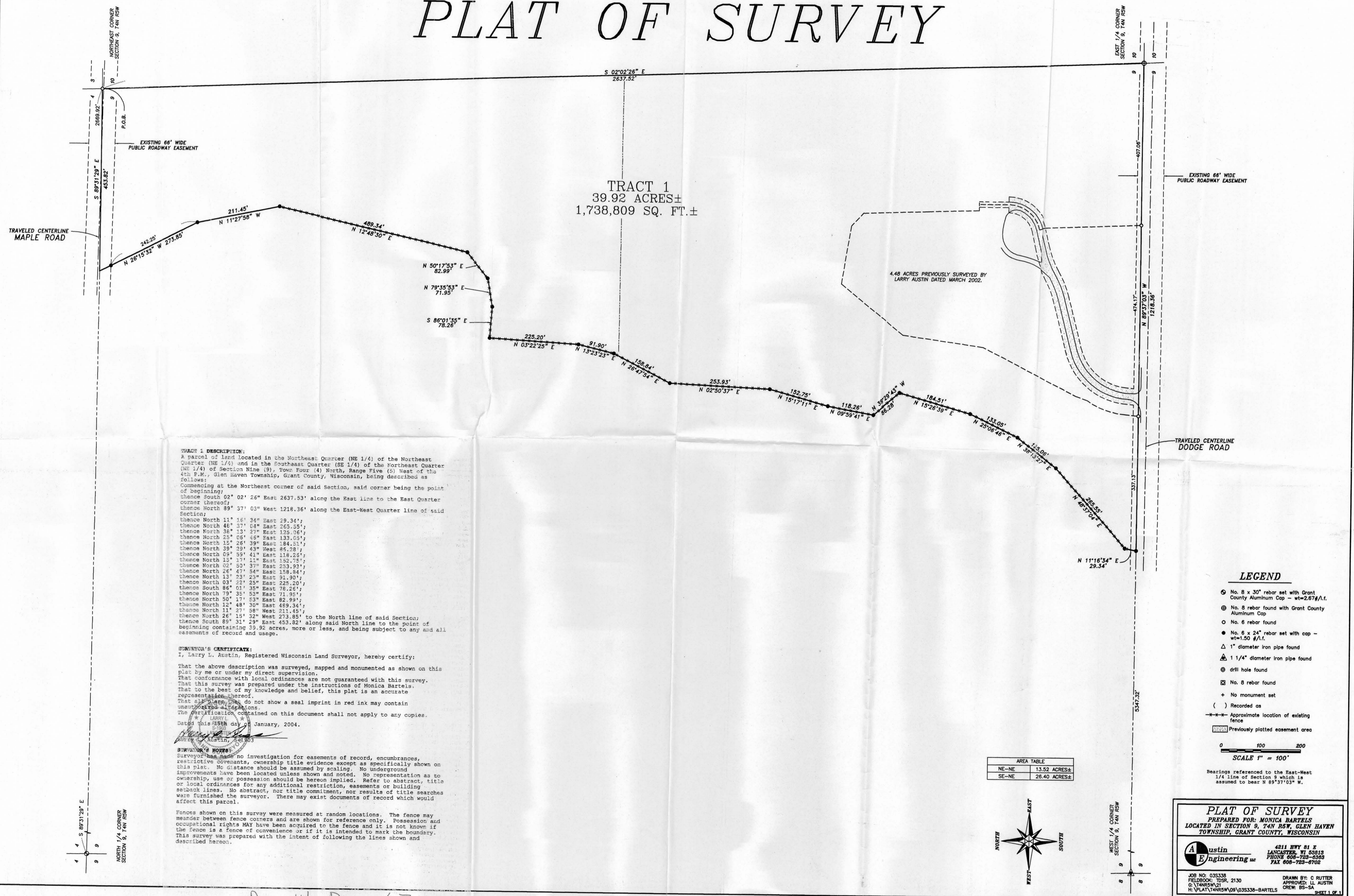


PLAT OF SURVEY

TRACT 1 DESCRIPTION:
A parcel of land located in the Northeast Quarter (NE 1/4) of the Northeast Quarter (NE 1/4) and in the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section Nine (9), Town Four (4) North, Range Five (5) West of the 4th P.M., Glen Haven Township, Grant County, Wisconsin, being described as follows:
Commencing at the Northeast corner of said Section, said corner being the point of beginning;
thence South 02° 02' 26" East 2637.53' along the East line to the East Quarter Corner thereof;
thence North 89° 37' 03" West 1218.36' along the East-West Quarter line of said Section;
thence North 11° 16' 34" East 29.34';
thence North 48° 37' 04" East 265.55';
thence North 36° 33' 27" East 125.06';
thence North 23° 06' 45" East 133.05';
thence North 15° 26' 39" East 184.51';
thence North 39° 29' 43" West 86.28';
thence North 09° 59' 41" East 118.26';
thence North 13° 17' 11" East 152.75';
thence North 02° 50' 37" East 253.93';
thence North 26° 47' 54" East 158.84';
thence North 13° 23' 23" East 91.90';
thence North 03° 22' 25" East 225.20';
thence South 86° 01' 35" East 78.26';
thence North 79° 35' 53" East 71.95';
thence North 12° 48' 30" East 489.34';
thence North 11° 27' 58" West 211.45';
thence North 26° 15' 32" West 273.85' to the North line of said Section;
thence South 89° 31' 29" East 453.82' along said North line to the point of beginning containing 39.92 acres, more or less, and being subject to any and all easements of record and usage.

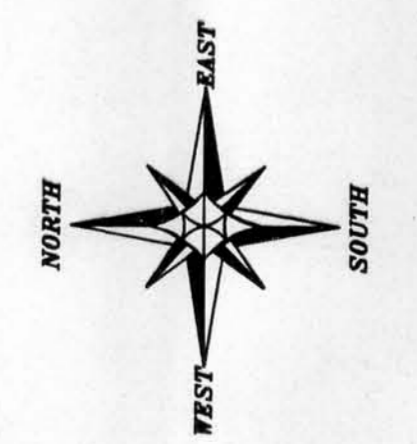
SURVEYOR'S CERTIFICATE:
