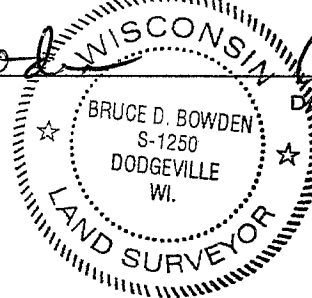

COMMENCING AT THE SOUTHEAST CORNER OF SECTION 27; THENCE S 89°47'34"W ON THE SOUTH LINE OF THE SOUTHEAST QUARTER, 541.69'; THENCE N 0°08'54"W, 164.35' TO A No.6(3/4" DIA.) REBAR AT THE POINT OF BEGINNING; THENCE CONTINUING N 0°08'54"W THROUGH A No.6 REBAR, 134.68' TO A POINT ON THE NORTH LINE OF LOT 1 OF BLOCK 44; THENCE S 89°59'51"W ON THE NORTH LINE OF BLOCK 44, 29.00' TO A No.6 REBAR; THENCE S 0°08'54"E, 134.68' TO A No.6 REBAR; THENCE N 89°59'53"E, 29.00' TO THE POINT OF BEGINNING. PARCEL CONTAINS 0.09 ACRES (3,906 SQ. FT.), MORE OR LESS, AND IS SUBJECT TO ANY AND ALL EASEMENTS AND RIGHTS-OF-WAY OF RECORD AND/OR USAGE.
