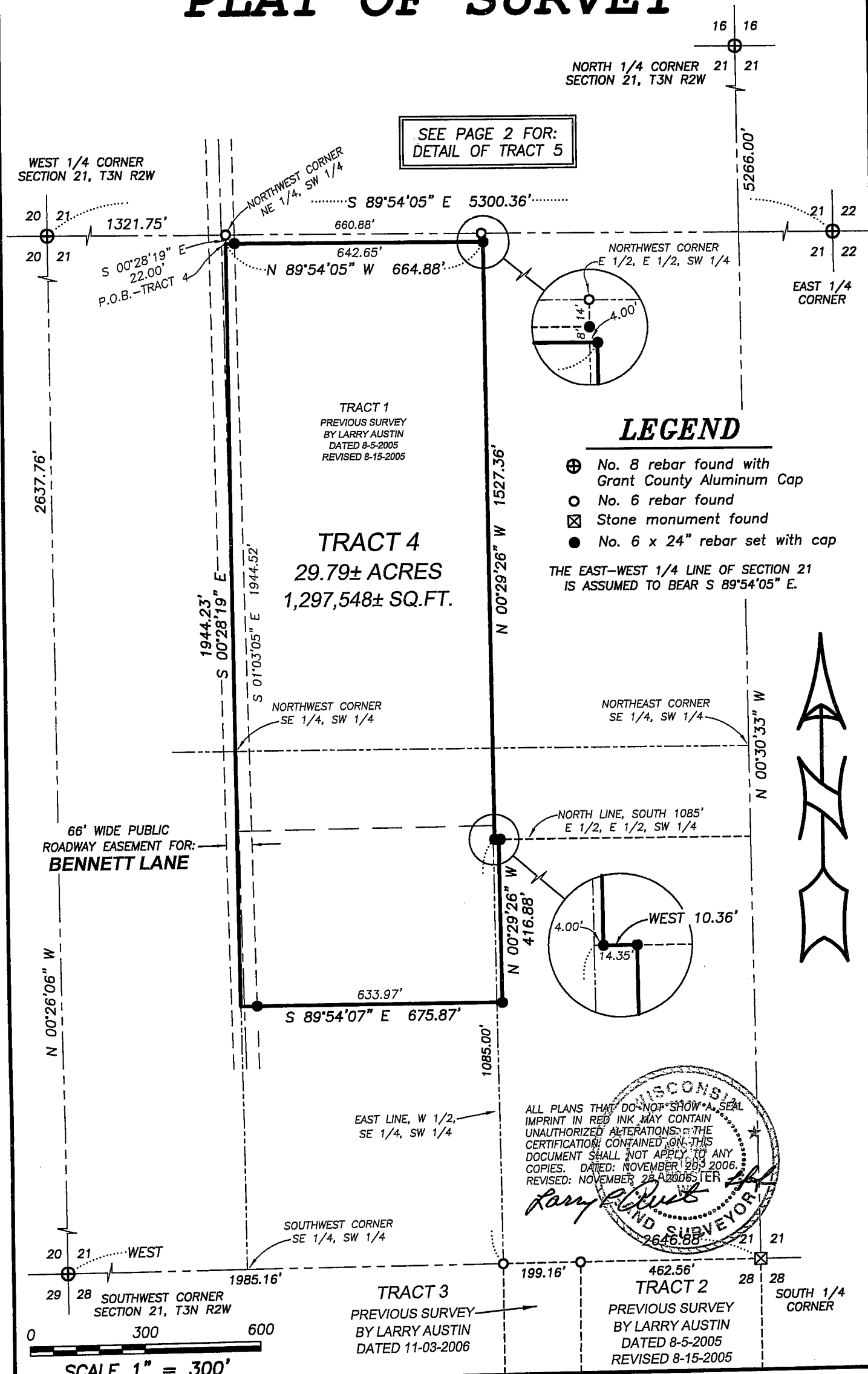
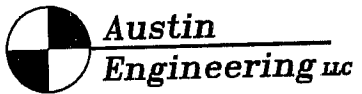

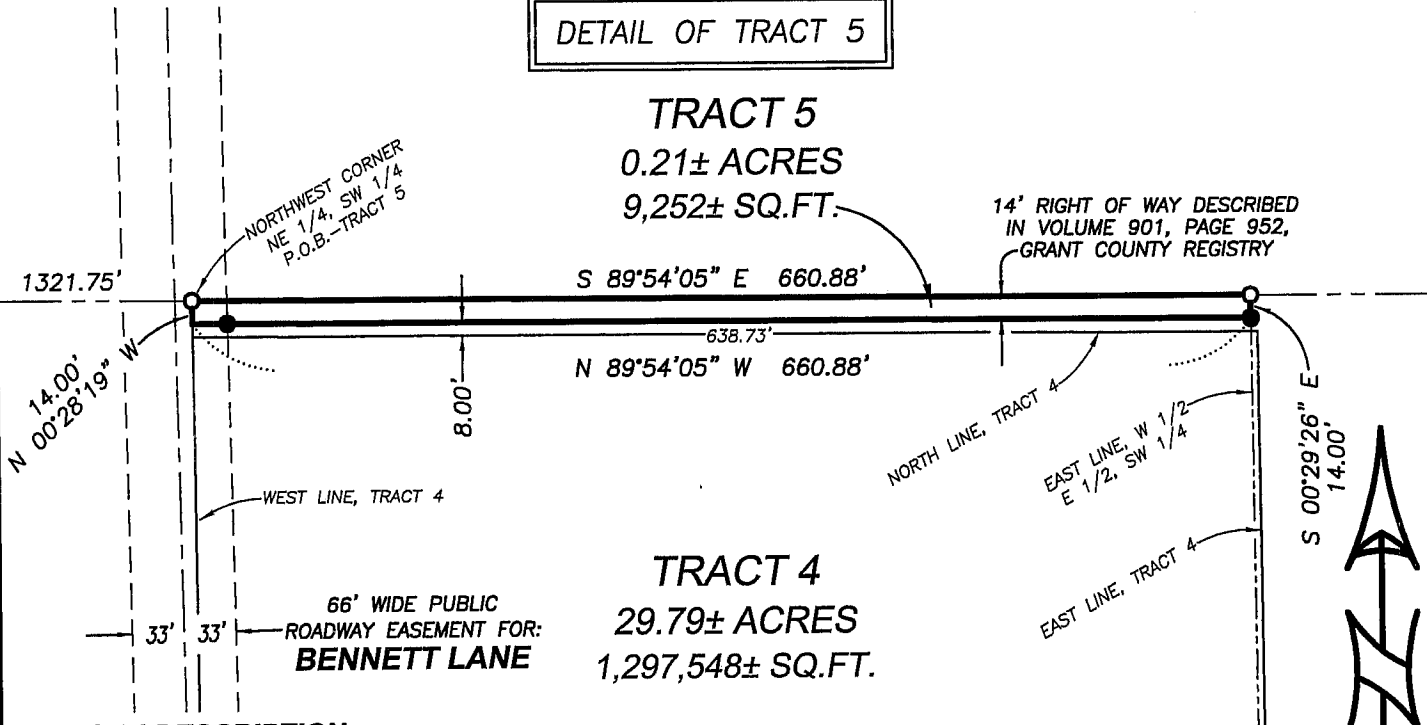

TRACT 4 DESCRIPTION:

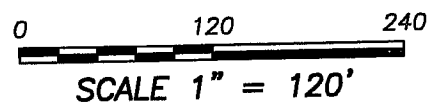
Part of the Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) and the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section Twenty-one (21), Town Three (3) North, Range Two (2) West of the 4th P.M., Harrison Township, Grant County, Wisconsin, containing 29.79 acres, more or less, and being described as follows: Commencing at the West Quarter (W 1/4) corner of said Section; thence South 89° 54' 05" East 1321.75' along the North line of the Southwest Quarter (SW 1/4) of said Section to the Northwest corner of the Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) thereof; thence South 00° 28' 19" East 22.00' along the West line of the East Half (E 1/2) of said Southwest Quarter (SW 1/4) to the point of beginning; thence South 00° 28' 19" East 1944.23' along said West line; thence South 89° 54' 07" East 675.87'; thence North 00° 29' 26" West 416.88' to the North line of the South 1085 feet of the East Half (E 1/2) of the East Half (E 1/2) of the Southwest Quarter (SW 1/4) thereof; thence West 10.36' along said North line; thence North 00° 29' 26" West 1527.36' to a point being Twenty-two feet (22') South of the North line of said Southwest Quarter (SW 1/4); thence North 89° 54' 05" West 664.88' parallel with the North line of said Southwest Quarter (SW 1/4) to the point of beginning. 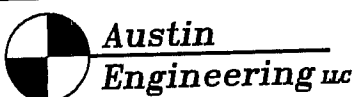

Tract being subject to any and all easements of record and \or usage.
