PARCEL DESCRIPTION:

A parcel of land located in part of the NW 1/4 of the SW 1/4, NE 1/4 of the SW 1/4, SE 1/4 of the SW 1/4, and SW 1/4 of the SW 1/4 of Section 13, T8N, R1W, Muscoda Township, Grant County, Wisconsin, to wit:
