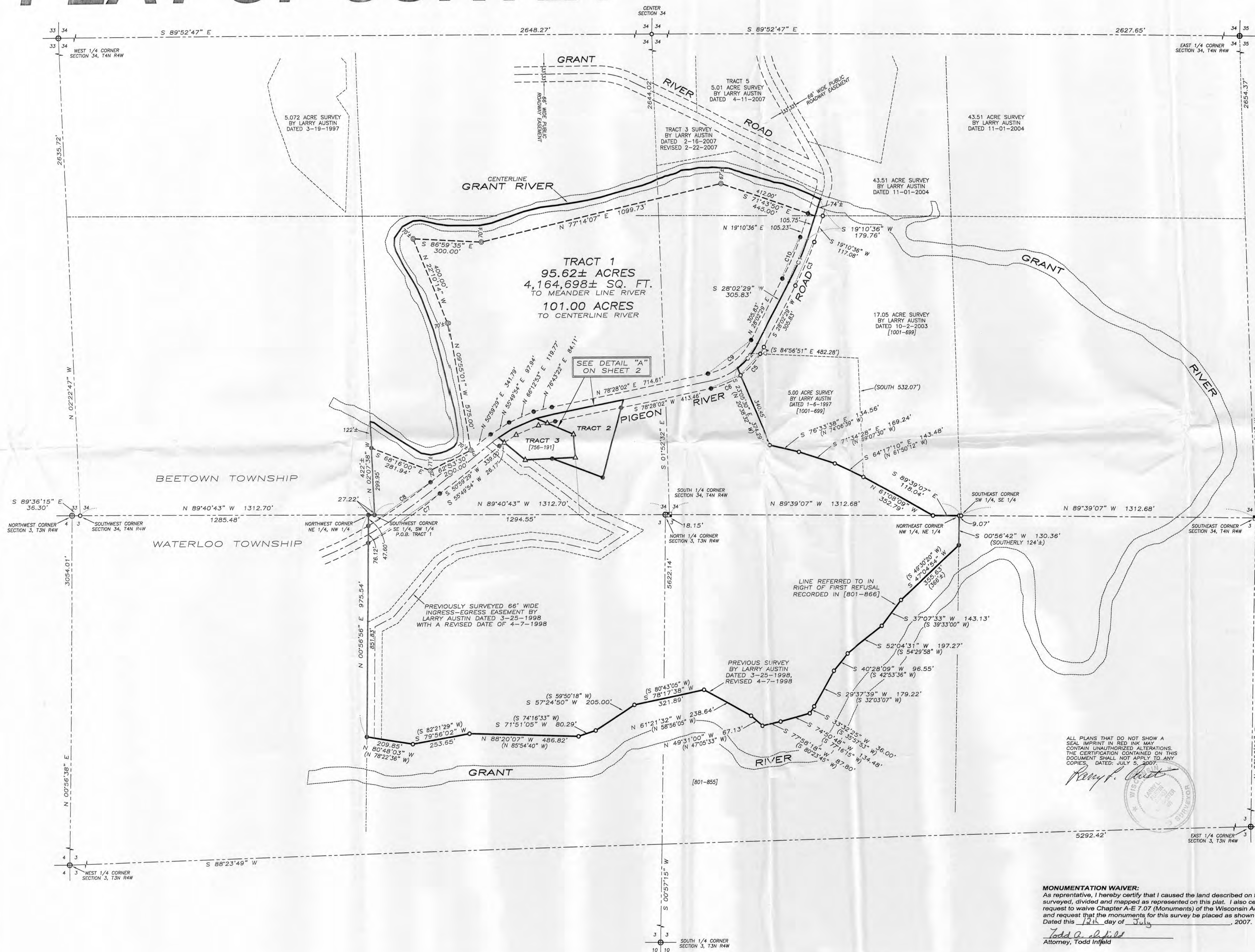
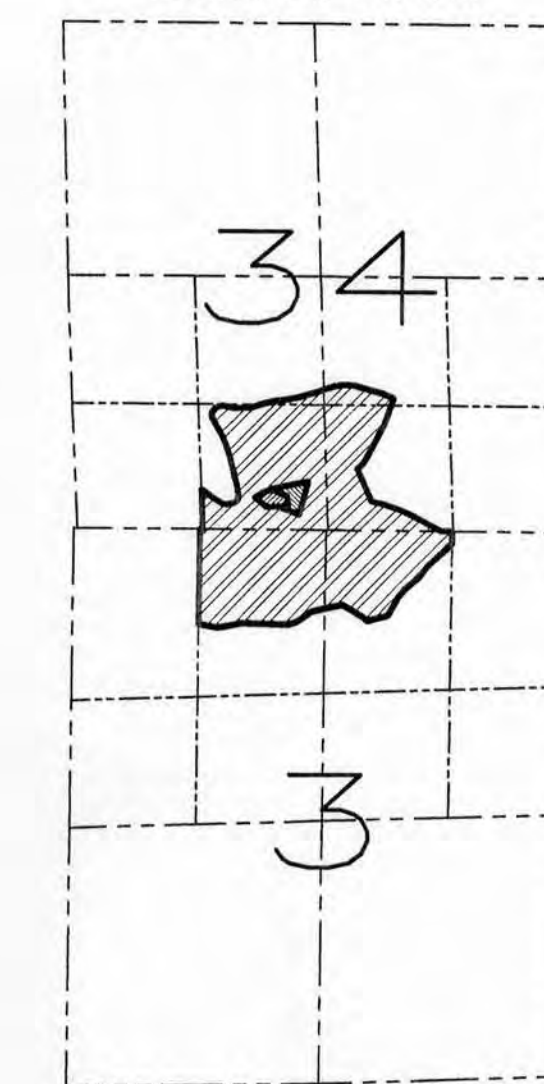


PLAT OF SURVEY



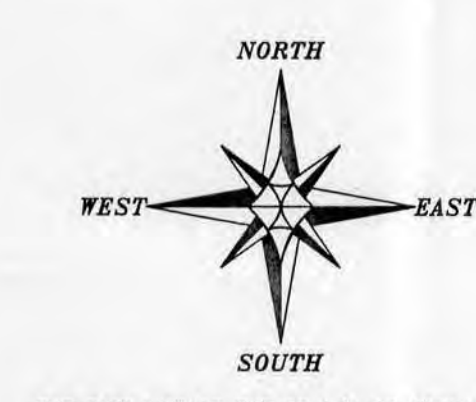
LOCATION SKETCH SECTION 3, T3N R4W SECTION 34, T4N R4W



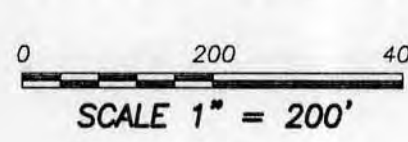

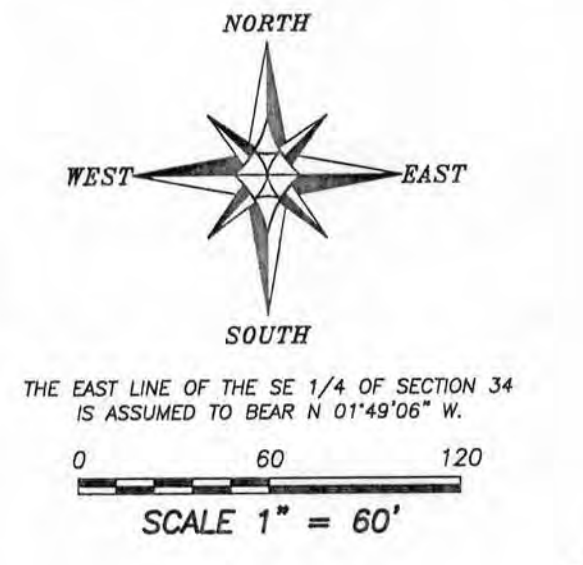

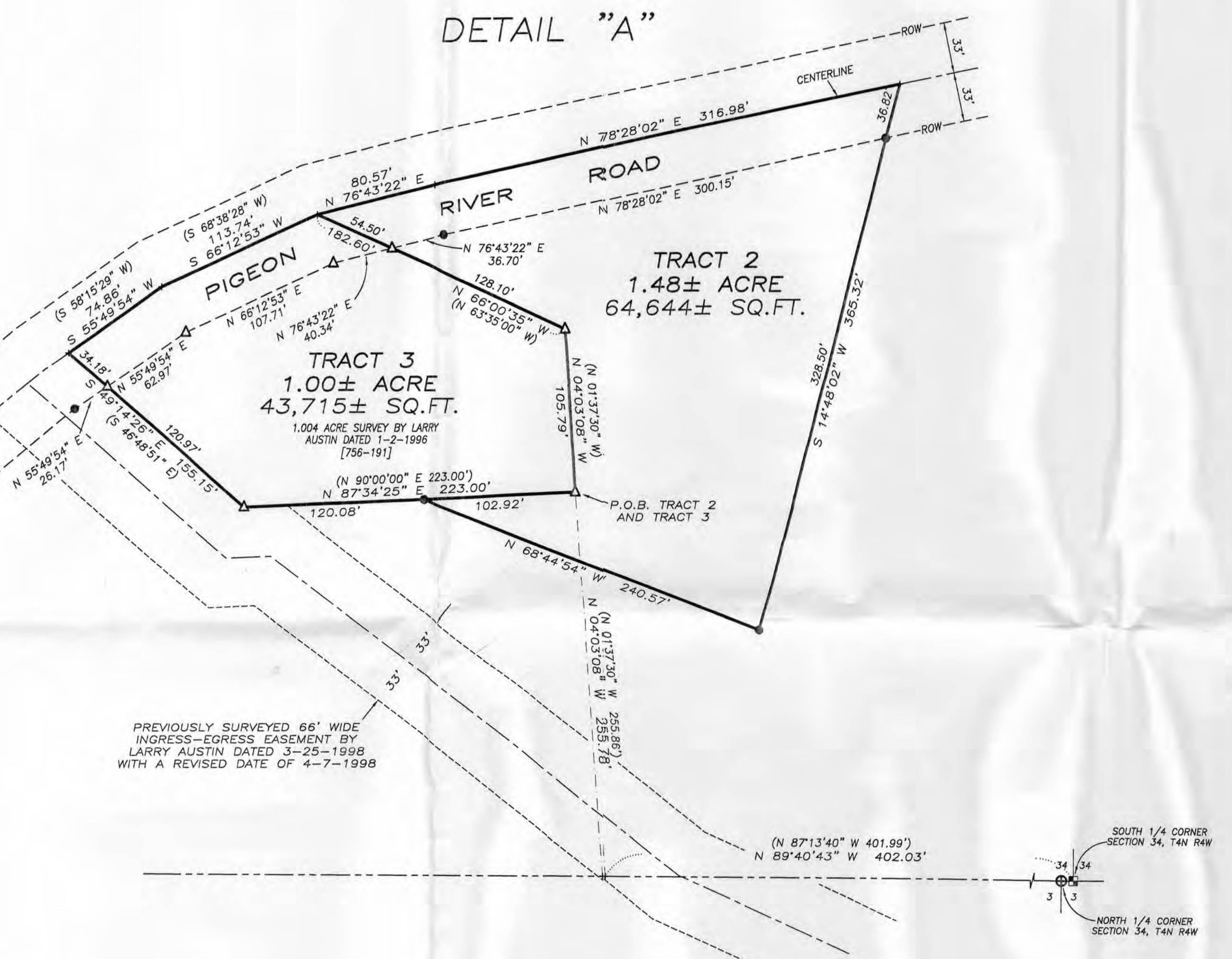
