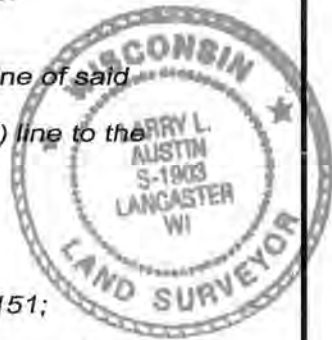

INGRESS-EGRESS EASEMENT DESCRIPTION:

A Sixty-six foot (66') wide ingress-egress easement being located in the Southwest Quarter (SW 1/4) of the Southeast Quarter (SE 1/4) of Section Twenty (20), Town Three (3) North, Range One (1) West of the 4th P.M., Platteville Township, Grant County, Wisconsin, and being described as follows:

Commencing at the South Quarter (S 1/4) corner of said Section;
thence North 01° 00' 05" West 41.01' along the North-South Quarter (N-S 1/4) line of said Section to the Northerly right of way of Short Lane;
thence North 88° 08' 44" East 380.19' along said Northerly right of way;
thence North 49° 19' 52" East 101.40' along said Northerly right of way;
thence South 53° 41' 29" East 39.14' along said Northerly right of way to the point of beginning;
thence South 53° 41' 29" East 66.05' along said Northerly right of way;
thence North 34° 01' 53" East 138.46';
thence 32.36' on the arc of a curve to the right having a radius of 34.00' and a long chord bearing North 61° 17' 52" East 31.15';
thence North 88° 33' 51" East 308.00';
thence North 01° 26' 09" West 66.00';
thence South 88° 33' 51" West 308.00';
thence 95.18' on the arc of a curve to the left having a radius of 100.00' and a long chord bearing South 61° 17' 52" West 91.63';


