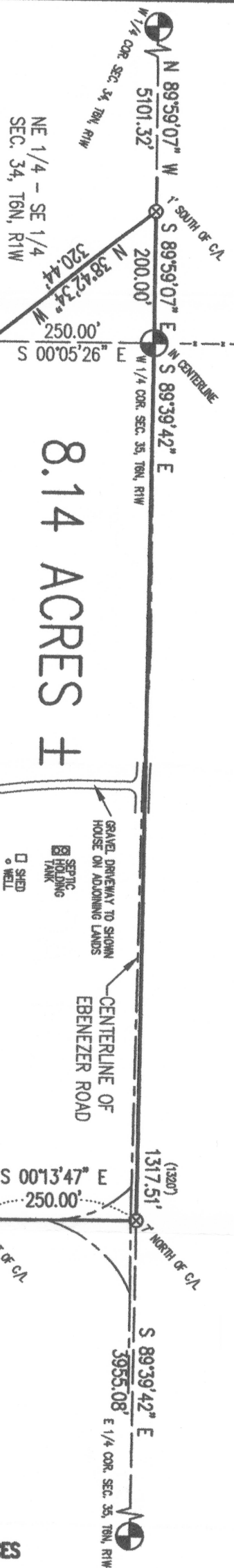

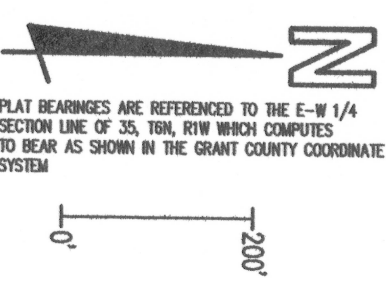

**PARCEL DESCRIPTION:**

A parcel of land located in part of the NE 1/4 of the SE 1/4 of Section 34 and NW 1/4 of the SW 1/4 of Section 35, all in T6N, R1W, Wingville Township, Grant County, Wisconsin, to wit:

Commencing at the W 1/4 CORNER of said Section 35; said point being the POINT OF BEGINNING; thence along the quarter section line, S 89° 39' 42" E, 1317.51' to the northeast corner of said NW 1/4 of the SW 1/4; thence along the east line of said forty, S 0° 13' 47" E, 250.00'; thence N 89° 39' 42" W, 1318.12'; thence N 38° 42' 34" W, 320.44' to the quarter section line; thence S 89° 59' 07" E, 200.00' to the POINT OF BEGINNING; said described parcel containing 8.14 acres, more or less. Parcel is subject to easements for Ebenezer Road along the northerly and LaPlatte Road along the easterly sides thereof. Parcel is subject to any easements, restrictions, and regulations of record.
