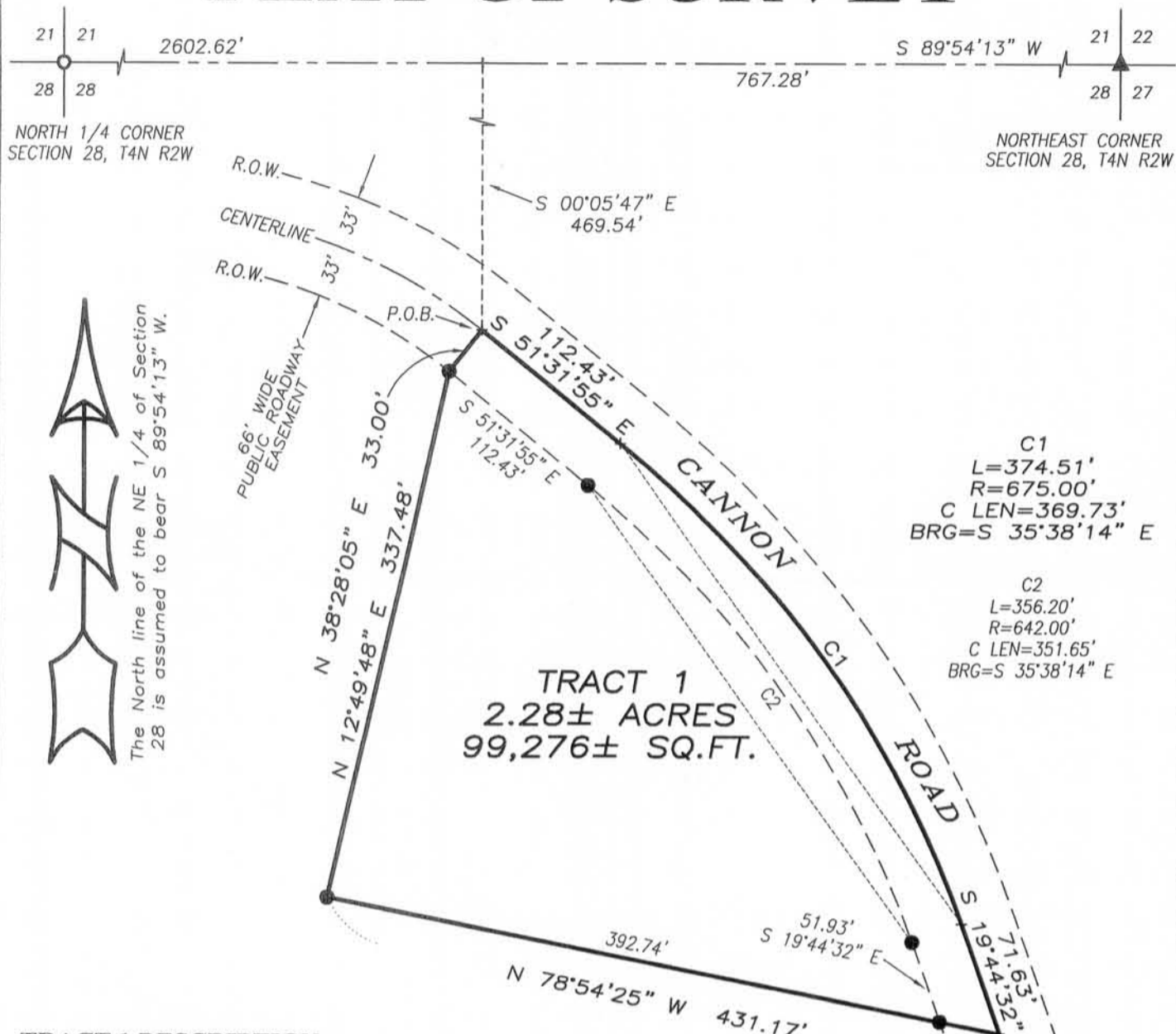


PLAT OF SURVEY



TRACT 1 DESCRIPTION:

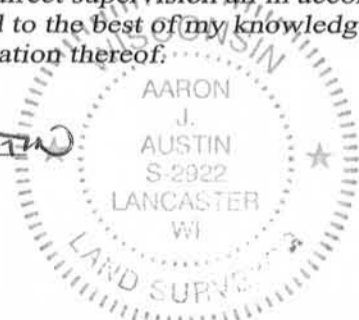
Located in the Northeast Quarter (NE 1/4) of the Northeast Quarter (NE 1/4) of Section Twenty-eight (28), Township Four (4) North, Range Two (2) West of the 4th P.M., Town of Ellenboro, Grant County, Wisconsin, containing 2.28 acres, more or less, and being described as follows:
 Commencing at the Northeast corner of said Section;
 thence South 89° 54' 13" West 767.28 feet along the North line of said Section;
 thence South 00° 05' 47" East 469.54 feet to a point in the centerline of a township road known as Cannon Road, said point being the point of beginning;
 thence South 51° 31' 55" East 112.43 feet along said centerline;
 thence 374.51 feet on the arc of a curve to the right having a radius of 675.00 feet and a long chord bearing South 35° 38' 14" East 369.73 feet along said centerline;
 thence South 19° 44' 32" East 71.63 feet along said centerline;
 thence North 78° 54' 25" West 431.17 feet to a No. 6 rebar;
 thence North 12° 49' 48" East 337.48 feet to a No. 6 rebar on the Southerly right of way of said Cannon Road;
 thence North 38° 28' 05" East 33.00 feet to the point of beginning. Tract being subject to any and all easements of record and/or usage.

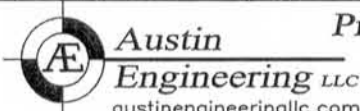
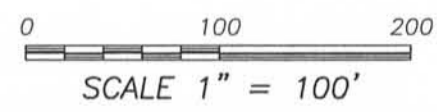
