COMMENCING AT THE NORTH QUARTER CORNER OF SECTION 28, TOWNSHIP 1 NORTH, RANGE 1 WEST OF THE FOURTH PRINCIPAL MERIDIAN; THENCE SOUTH 01 DEGREES 16 MINUTES 10 SECONDS WEST, ALONG THE NORTH-SOUTH ONE-HALF LINE OF SAID SECTION 28, A DISTANCE OF 1,897.47 FEET; THENCE NORTH 90 DEGREES 00 MINUTES 00 SECONDS EAST, 1,303.11 FEET TO A POINT ON THE NORTHERLY RIGHT-OF-WAY LINE OF STATE TRUNK HIGHWAY NO. 11, AS DESCRIBED IN THE WARRANTY DEED RECORDED AS DOCUMENT NO. 561435, IN VOLUME NO. 716, PAGES 316 THROUGH 318, AND ALSO AS DESCRIBED IN THE WARRANTY DEED RECORDED AS DOCUMENT NO. 561480, IN VOLUME 716, PAGES 442 THROUGH 445, ALL IN THE OFFICE OF THE GRANT COUNTY REGISTER OF DEEDS, SAID POINT ALSO BEING THE POINT OF BEGINNING; THENCE NORTH 59 DEGREES 36 MINUTES 59 SECONDS EAST, ALONG SAID NORTHERLY RIGHT-OF-WAY LINE, A DISTANCE OF 196.00 FEET; THENCE NORTH 61 DEGREES 47 MINUTES 28 SECONDS EAST, ALONG SAID NORTHERLY RIGHT-OF-WAY LINE, A DISTANCE OF 164.03 FEET; THENCE NORTH 28 DEGREES 12 MINUTES 32 SECONDS WEST, 300.00 FEET; THENCE SOUTH 60 DEGREES 36 MINUTES 40 SECONDS WEST, 371.00 FEET; THENCE SOUTH 30 DEGREES 19 MINUTES 00 SECONDS EAST, 300.00 FEET TO THE POINT OF BEGINNING, SAID TRACT CONTAINING 2.50 ACRES (109,016 SQUARE FEET), MORE OF LESS, SUBJECT TO ANY AND ALL RECORDED EASEMENTS AND RIGHT-OF-WAYS, ALL BEING SITUATED IN HAZEL GREEN TOWNSHIP, GRANT COUNTY, WISCONSIN.
