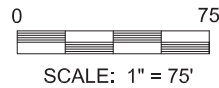

 THENCE S81°43'57"E, 266.18 FEET TO THE POINT OF BEGINNING.

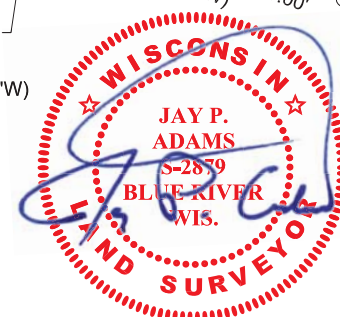

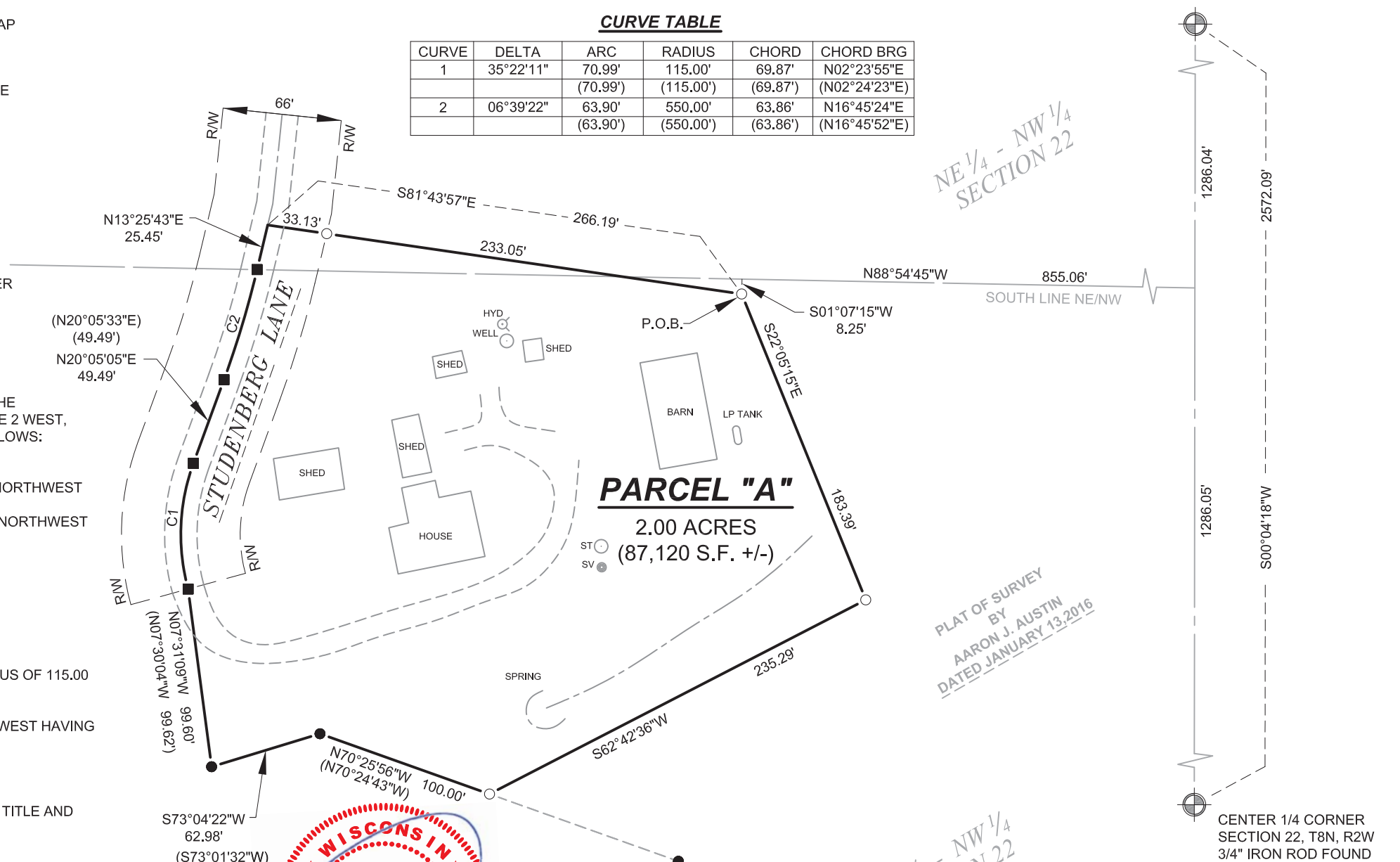
