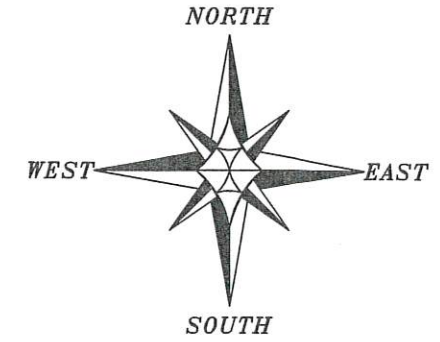

DESCRIPTION:

Located in the Northeast Quarter (NE 1/4) of the Southwest Quarter (SW 1/4) of Section Twenty-nine (29), Township Four (4) North, Range Three (3) West of the 4th P.M., Town of South Lancaster, Grant County, Wisconsin, containing 0.97 acre, more or less, and being described as follows:

Commencing at the West Quarter (W 1/4) corner of said Section 29;
thence South 89° 04' 30" East 2419.95 feet along the East-West Quarter (E-W 1/4) line of said Section to the point of beginning;
thence South 89° 04' 30" East 234.00 feet along said East-West Quarter (E-W 1/4) line to the center of said Section;
thence South 01° 34' 17" East 181.00 feet along the North-South Quarter (N-S 1/4) line;
thence North 89° 04' 30" West 234.00 feet;
thence North 01° 34' 17" West 181.00 feet to the point of beginning.

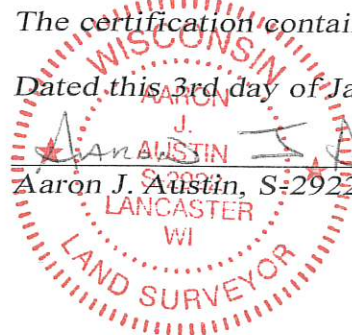
