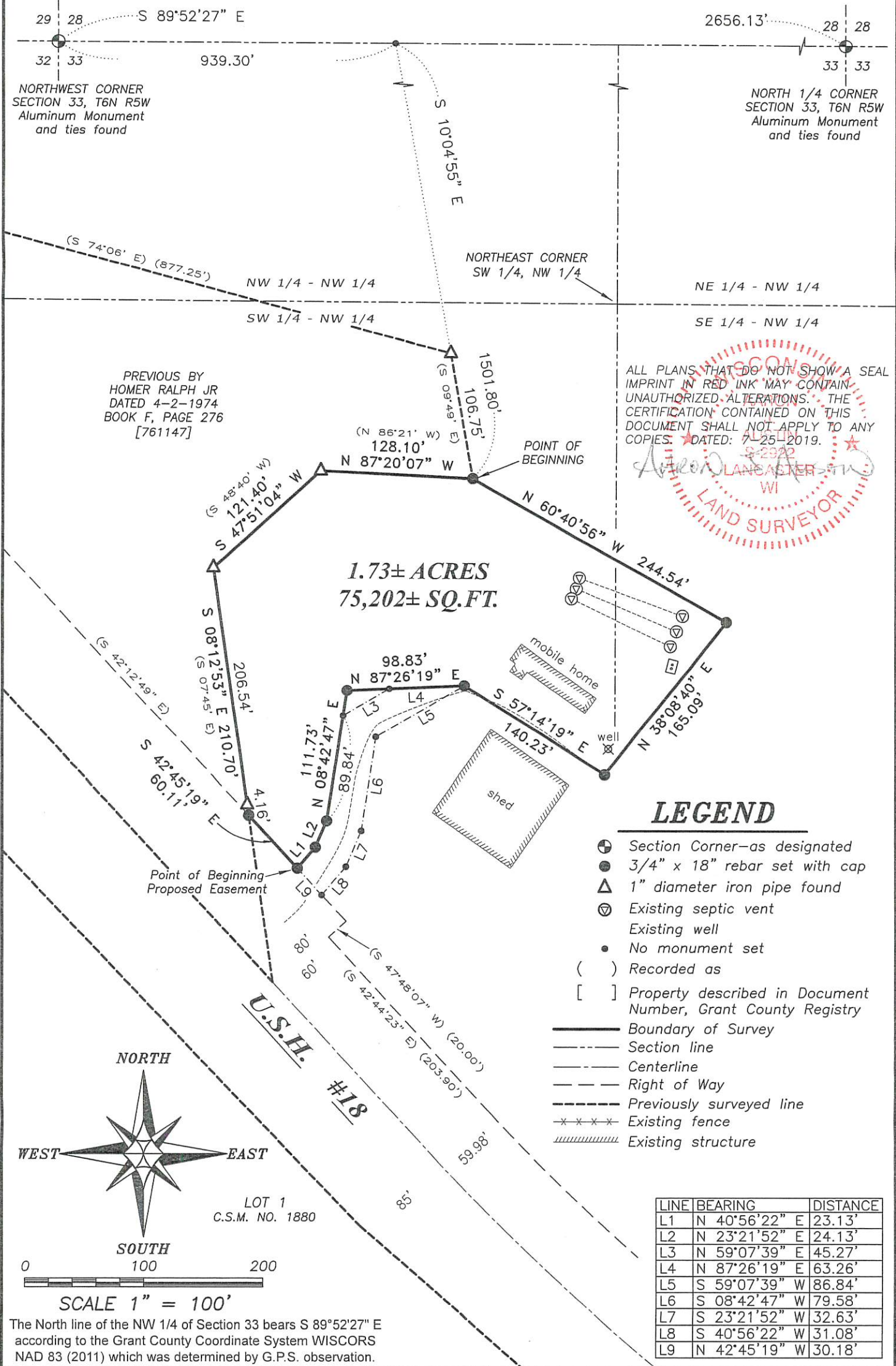

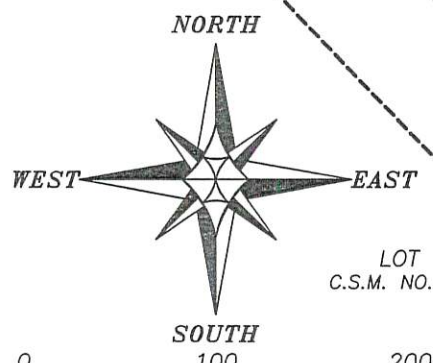

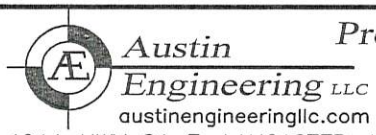

PLAT OF SURVEY

DESCRIPTION:

Located in the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) and the Southeast Quarter (SE 1/4) of the Northwest Quarter (NW 1/4) of Section Thirty-three (33), Township Six (6) North, Range Five (5) West of the 4th P.M., Town of Patch Grove, Grant County, Wisconsin, containing 1.73 acres, more or less, and being described as follows:

Commencing at an Aluminum Monument marking the Northwest corner of said Section 33; thence South 89° 52' 27" East 939.30 feet along the North line of said Section 33; thence South 10° 04' 55" East 1501.80 feet to a 3/4" rebar marking the point of beginning; thence North 87° 20' 07" West 128.10 feet along a line of that property as described in Document Number 761147, Grant County Registry to a 1" iron pipe; thence South 47° 51' 04" West 121.40 feet along a line of said property to a 1" iron pipe; thence South 08° 12' 53" East 210.70 feet along a line of said property to a 3/4" rebar on the Northeasterly right of way of U.S.H. #18; thence South 42° 45' 19" East 60.11 feet along said right of way to a 3/4" rebar; thence North 40° 56' 22" East 23.13 feet to a 3/4" rebar; thence North 23° 21' 52" East 24.13 feet to a 3/4" rebar; thence North 08° 42' 47" East 111.73 feet to a 3/4" rebar; thence North 87° 26' 19" East 98.83 feet to a 3/4" rebar; thence South 57° 14' 19" East 140.23 feet to a 3/4" rebar; thence North 38° 08' 40" East 165.09 feet to a 3/4" rebar; thence North 60° 40' 56" West 244.54 feet to the point of beginning. Tract being subject to any and all easements of record and/or usage.

PROPOSED ACCESS EASEMENT:

A Thirty foot (30') wide access easement for ingress-egress which is located in the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of Section Thirty-three (33), Township Six (6) North, Range Five (5) West of the 4th P.M., Town of Patch Grove, Grant County, Wisconsin, said Easement being described as follows:

Commencing at an Aluminum Monument marking the Northwest corner of said Section 33; thence South 89° 52' 27" East 939.30 feet along the North line of said Section 33; thence South 10° 04' 55" East 1501.80 feet to a 3/4" rebar; thence North 87° 20' 07" West 128.10 feet along a line of that property as described in Document Number 761147, Grant County Registry to a 1" iron pipe; thence South 47° 51' 04" West 121.40 feet along a line of said property to a 1" iron pipe; thence South 08° 12' 53" East 210.70 feet along a line of said property to a 3/4" rebar on the Northeasterly right of way of U.S.H. #18; thence South 42° 45' 19" East 60.11 feet along said right of way to a 3/4" rebar to the point of beginning; thence North 40° 56' 22" East 23.13 feet to a 3/4" rebar; thence North 23° 21' 52" East 24.13 feet to a 3/4" rebar; thence North 08° 42' 47" East 89.84 feet; thence North 59° 07' 39" East 45.27 feet; thence North 87° 26' 19" East 63.26 feet; thence South 59° 07' 39" West 86.84 feet; thence South 08° 42' 47" West 79.58 feet; thence South 23° 21' 52" West 32.63 feet; thence South 40° 56' 22" West 31.08 feet to the Northeasterly right of way of U.S.H. #18; thence North 42° 45' 19" West 30.18 feet along said right of way to the point of beginning.

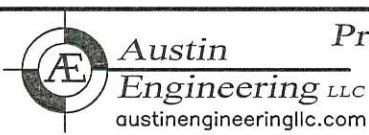
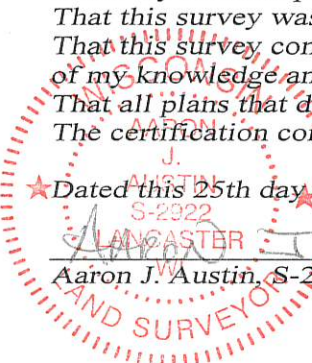
