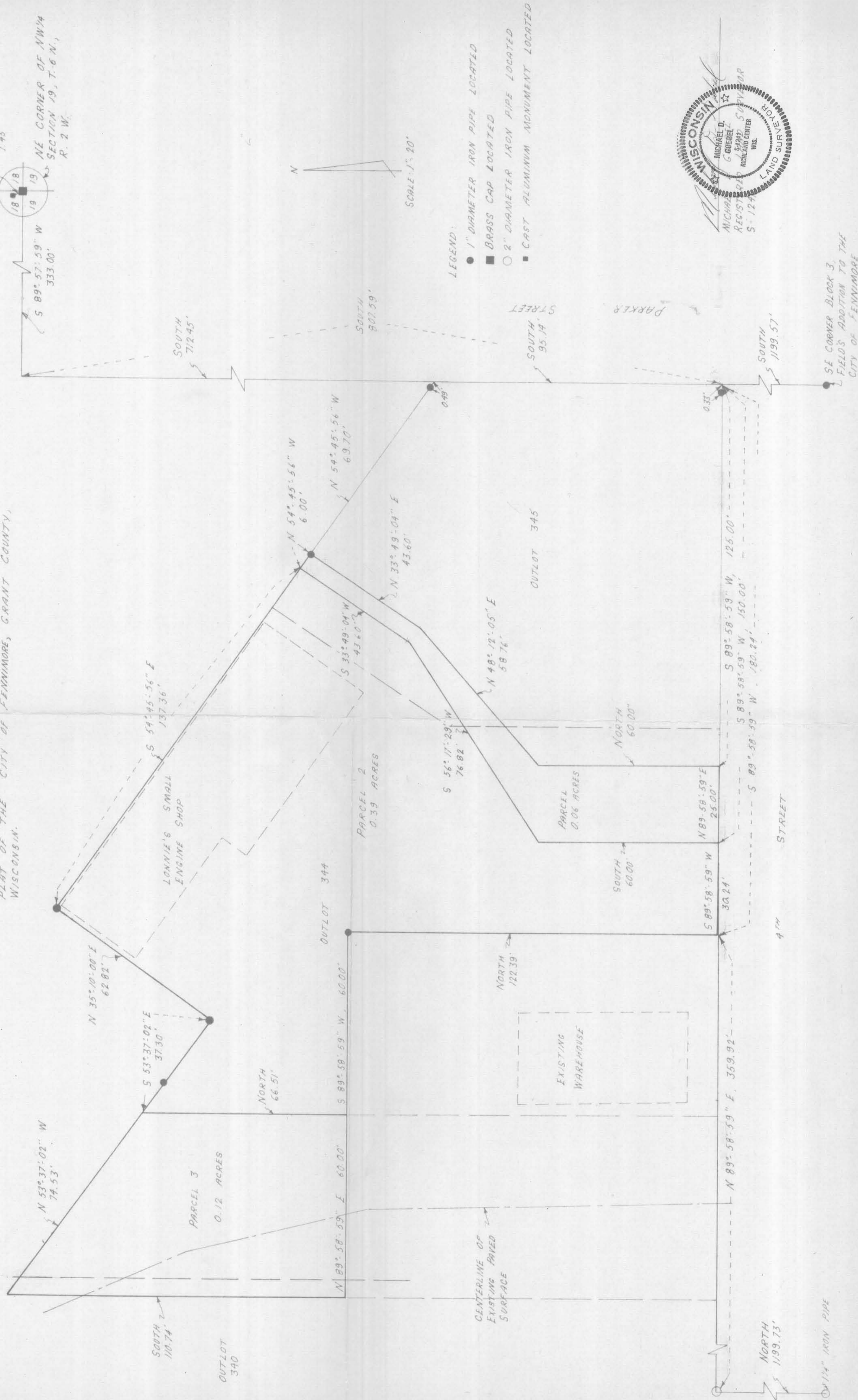
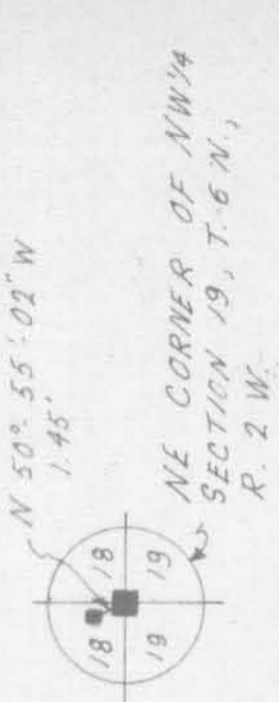

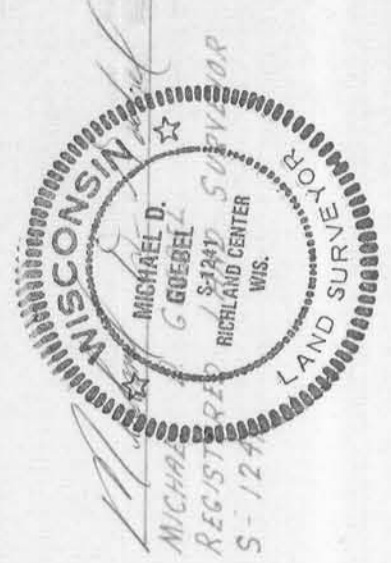
LOCATED PARTLY IN OUTLOT 340, PARTLY IN OUTLOT 344
