DESCRIPTION:

A part of the Northwest Quarter (NW $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 16, Township 1 North, Range 2 West of the Fourth Principal Meridian, bounded and described as follows, to-wit:

Commencing at the Southwest Corner of the Northwest Quarter (NW $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of said Section 16; thence South 89 degrees - 05 minutes - 00 seconds East, a distance of 235.48 feet to the point of beginning of the hereinafter described tract of land; thence South 89 degrees - 05 minutes - 00 seconds East, a distance of 461.79 feet to the Westerly right-of-way line of Wisconsin Route 35; thence North 07 degrees - 42 minutes - 17 seconds West on said Westerly right-of-way line, a distance of 150.65 feet; thence North 90 degrees - 00 minutes - 00 seconds West on said Westerly right-of-way line, a distance of 20.00 feet; thence North 00 degrees - 52 minutes - 00 seconds East on said Westerly right-of-way line, a distance of 45.55 feet; thence North 87 degrees - 38 minutes - 31 seconds West, a distance of 263.06 feet; thence South 65 degrees - 57 minutes - 26 seconds West, a distance of 170.46 feet; thence South 01 degree - 02 minutes - 21 seconds West, a distance of 128.84 feet to the point of beginning, containing 1.89 acres more or less, subject to roadway easements and any other easements of record.
