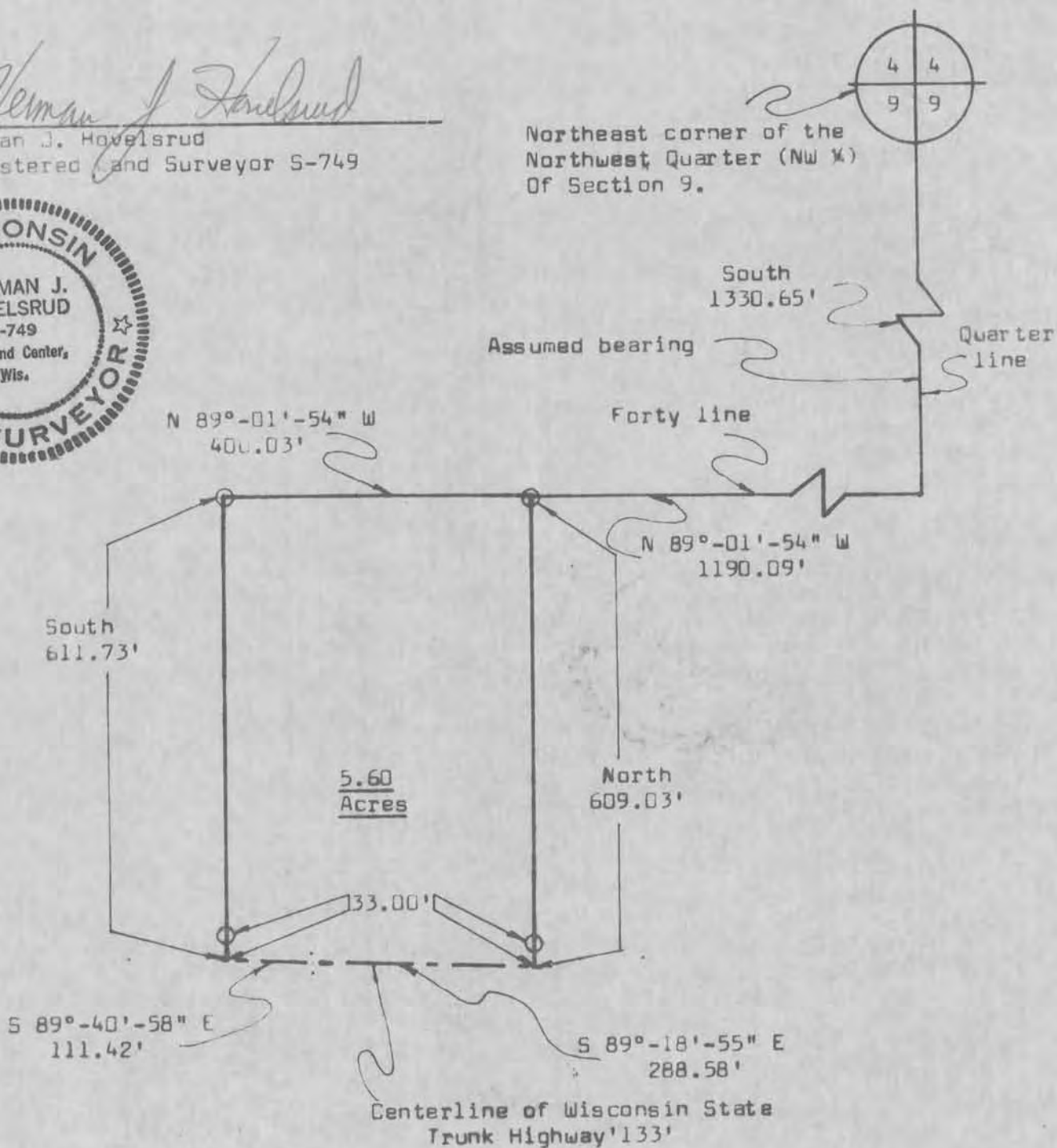

A SURVEY of a PARCEL of LAND Described as Follows:

Commencing at the Northeast corner of the Northwest Quarter ($NW\frac{1}{4}$) of Section 9, T. 8 N., R. 1 W., Grant County, Wisconsin; Thence South, 1330.65 feet along the East line of said Northwest Quarter; Thence N $89^{\circ}-01'-54''$ W, 1190.09 feet along the North line of the Southeast Quarter ($SE\frac{1}{4}$) of said Northwest Quarter ($NW\frac{1}{4}$) to a 1 inch diameter iron pipe and the point of beginning;

Thence N $89^{\circ}-01'-54''$ W, 400.03 feet along said North line and the North line of the Southwest Quarter ($SW\frac{1}{4}$) of said Northwest Quarter ($NW\frac{1}{4}$) to a 1 inch diameter iron pipe;

Thence South, 611.73 feet to a point in the centerline of Wisconsin State Trunk Highway "133";

Thence S $89^{\circ}-40'-58''$ E, 111.42 feet to a point in said centerline;


Thence S $89^{\circ}-18'-55''$ E, 288.58 feet to a point in said centerline;

Thence North, 609.03 feet to the point of beginning;

The above described parcel of land being located partly in the Southeast Quarter ($SE\frac{1}{4}$) of the Northwest Quarter ($NW\frac{1}{4}$) and partly in the Southwest Quarter ($SW\frac{1}{4}$) of the Northwest Quarter ($NW\frac{1}{4}$), all in Section 9, T. 8 N., R. 1 W., Grant County, Wisconsin, and containing 5.60 acres and being subject to conveyances for roadway purposes.
