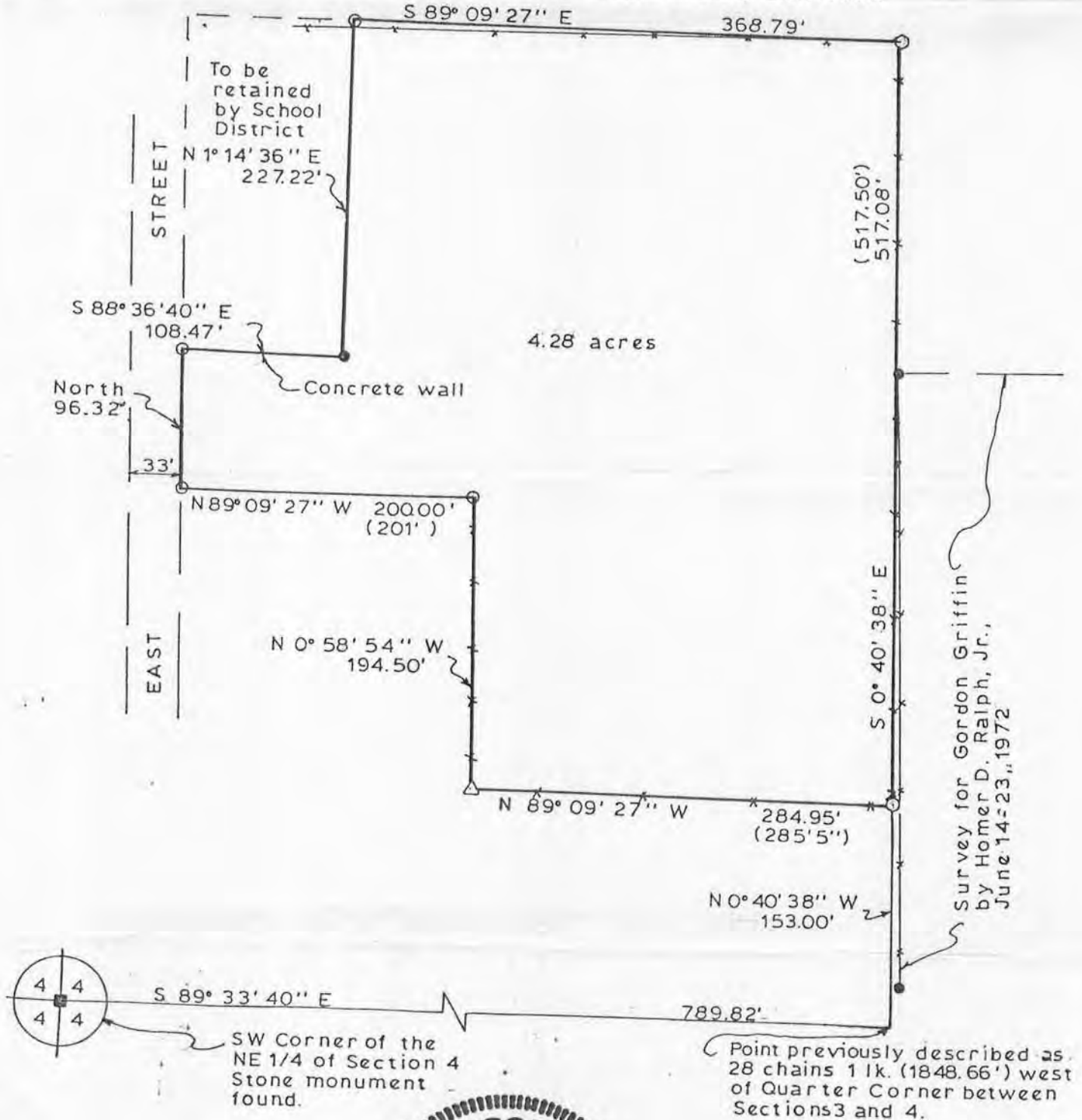

Commencing at an existing stone monument at the Southwest Corner of the Northeast Quarter (NE $\frac{1}{4}$) of Section 4, T. 5 N., R. 5 W., Grant County, Wisconsin; Thence S 89°-33'-40" E, 789.82 feet to a point previously described as being 28 chains and 1 link West of the Quarter-Corner between Sections 3 and 4; Thence N 0°-40'-38" W, 153.00 feet to the point of beginning;

Thence N 89°-09'-27" W, 284.95 feet;
Thence N 0°-58'-54" W, 194.50 feet;
Thence N 89°-09'-27" W, 200.00 feet to a point on the Easterly right-of-way limit of East Street;
Thence North, 96.32 feet along said right-of-way limit;
Thence S 88°-36'-40" E, 108.47 feet;
Thence N 1°-14'-36" E, 227.22 feet;
Thence S 89°-09'-27" E, 368.79 feet;
Thence S 0°-40'-38" E, 517.08 feet to the point of beginning;
