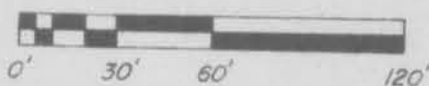

Scale: 1" = 60'



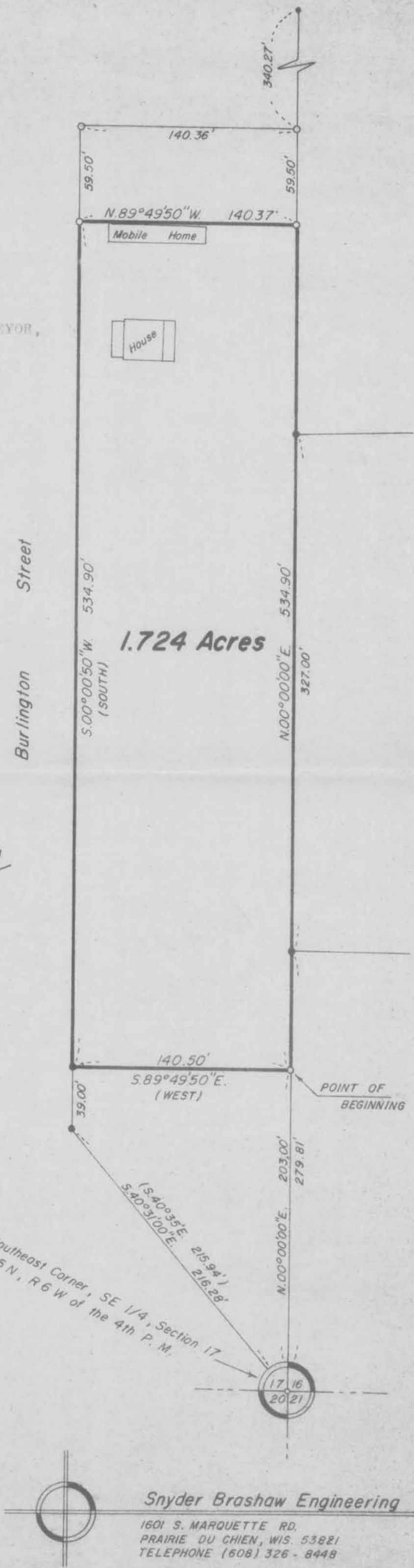
Village of Bagley
