

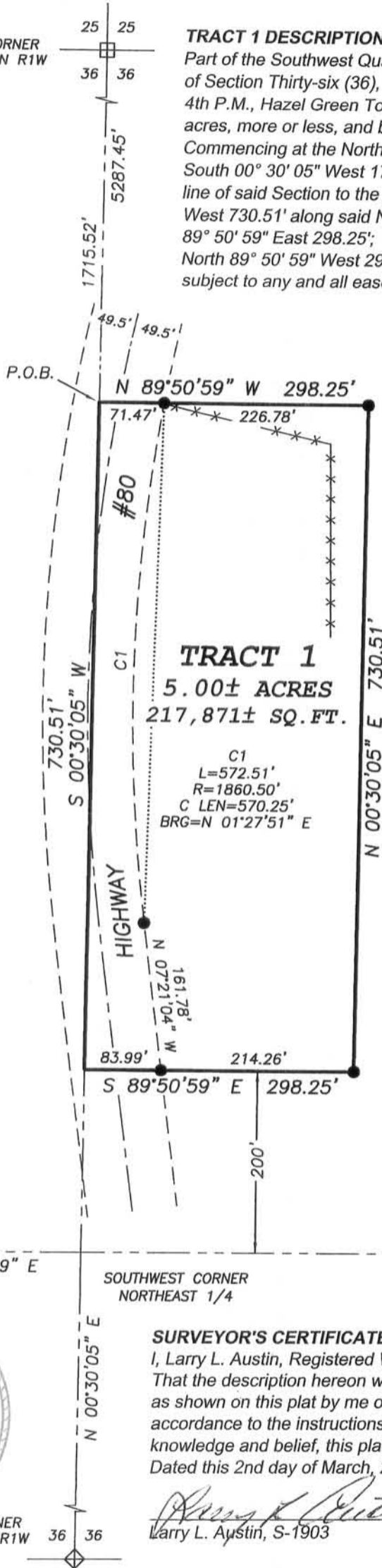
PLAT OF SURVEY

NORTH 1/4 CORNER

TRACT 1 DESCRIPTION:

Part of the Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of Section Thirty-six (36), Town One (1) North, Range One (1) West of the 4th P.M., Hazel Green Township, Grant County, Wisconsin, containing 5.00 acres, more or less, and being described as follows:

Commencing at the North Quarter (N 1/4) corner of said Section; thence South 00° 30' 05" West 1715.52' along the North-South Quarter (N-S 1/4) line of said Section to the point of beginning; thence South 00° 30' 05" West 730.51' along said North-South Quarter (N-S 1/4) line; thence South 89° 50' 59" East 298.25'; thence North 00° 30' 05" East 730.51'; thence North 89° 50' 59" West 298.25' to the point of beginning. Tract being subject to any and all easements of record and/or usage.

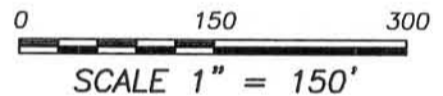
