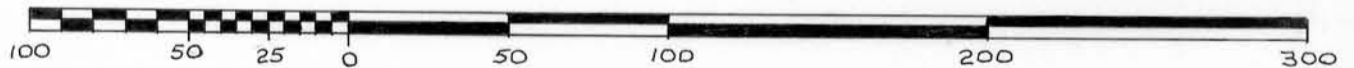

DESCRIPTION:

Part of the S.E.1/4 of the S.E.1/4 of Section 27, and part of the N.E.1/4 of the N.E.1/4 of Section 34, all in T 3 N, R 3 W, of the 4th P.M., Grant County, Wisconsin, described as follows to-wit:

Commence at the Northeast Corner of said Section 34;
thence South 41° 51' West 278.00 feet;
thence North 48° 09' West 25.00 feet to the point of beginning;
thence South 41° 51' West 305.00 feet;
thence North 48° 09' West 90.00 feet;
thence South 41° 51' West 241.00 feet;
thence South 48° 09' East 90.00 feet;
thence South 41° 51' West 127.22 feet to the centerline of State Trunk Highway #133;
thence South 74° 53' West 87.76 feet along said centerline;
thence North 02° 03' East 189.40 feet;
thence North 10° 16' East 235.90 feet;
thence North 18° 09' East 394.20 feet;
thence South 66° 39' East 294.56 feet;
thence South 33° 05' West 61.66 feet;
thence South 52° 34' East 81.83 feet;
thence South 48° 09' East 81.00 feet to the point of beginning.
