Commencing at the Southeast Corner of Lot 1 of Southfield Subdivision, the City of Lancaster, Grant County, Wisconsin; Thence N 88°-54'-00" W, 6.81 feet; Thence N 1°-07'-52" W, 170.64 feet; Thence N 3°-57'-42" E, 41.99 feet to a 1 inch diameter iron pipe in an existing fenceline and the point of beginning;

Thence N 3°-57'-42" E, 226.41 feet along said fence line and said fence line extended to a point in the centerline of Schreiner Park Road;


Thence S 54°-04'-31" E, 85.55 feet to a point in said centerline;

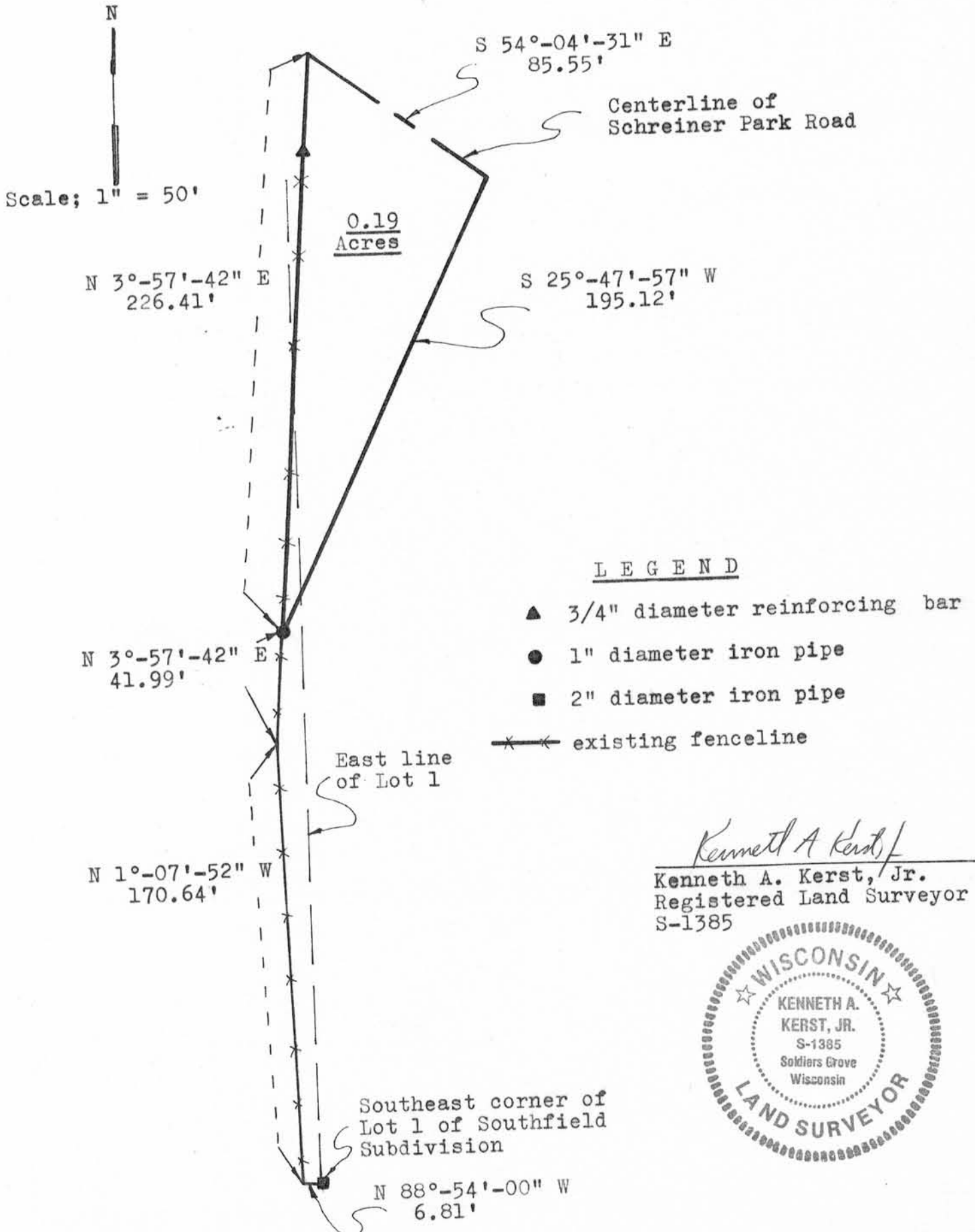
