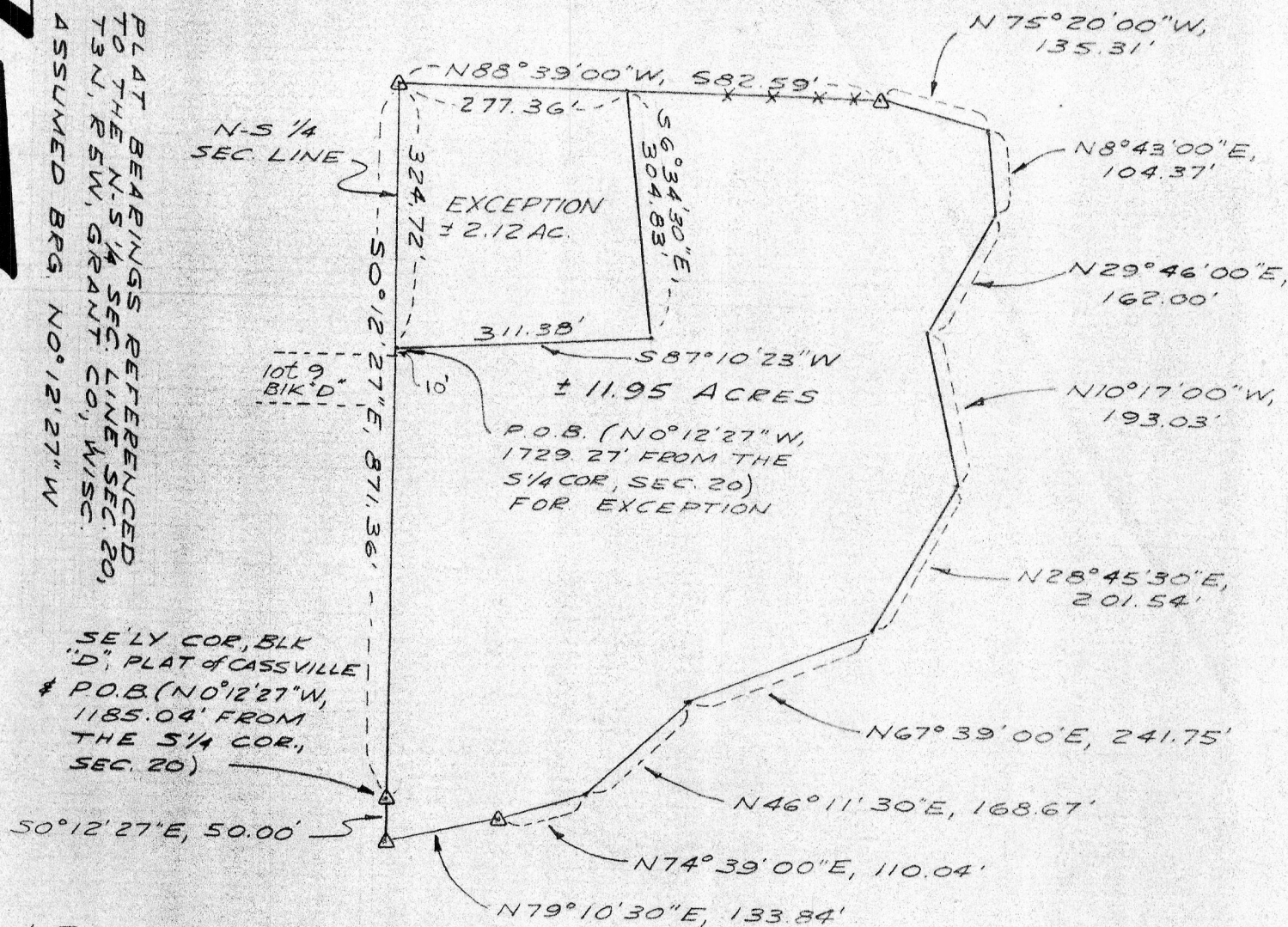

PARCEL DESCRIPTION

A parcel of land located in the NW 1/4 of the SE 1/4 and SW 1/4 of the SE 1/4, Section 20, T3N, R5W, Grant County, Wisconsin, described as follows:
 Commencing at the South 1/4 corner of said Sec. 20; thence N 0° 12' 27" W, 1185.04' along the N-S 1/4 section line of said Sec. 20 to the southeasterly corner of Block "D" of the Plat of Cassville, said point being the point of beginning and being marked by a 1" iron pipe; thence S 0° 12' 27" E, 50' to a 1" iron pipe; thence N 79° 10' 30" E, 133.84' to a 1" iron pipe; thence N 74° 39' E, 110.04'; thence N 46° 11' 30" E, 168.67'; thence N 67° 39' E, 241.75'; thence N 28° 45' 30" E, 201.54'; thence N 10° 17' W, 193.03'; thence N 8° 43' E, 104.37'; thence N 75° 20' W, 135.31' to a 1" iron pipe; thence N 88° 39' W, 582.59' to a 1" iron pipe lying on said 1/4 section line; thence S 0° 12' 27" E, 871.36' along said 1/4 section line to the point of beginning.
 Said parcel contains 11.95 acres, more or less.

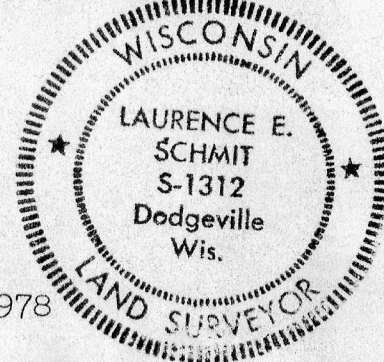
