Thence N 32°-01'-56" W, 99.71 feet to the point of intersection of said centerline of a private drive with the centerline of Collins Road;


Thence N 2°-46'-29" W, 69.89 feet to a point in said centerline of Collins Road;

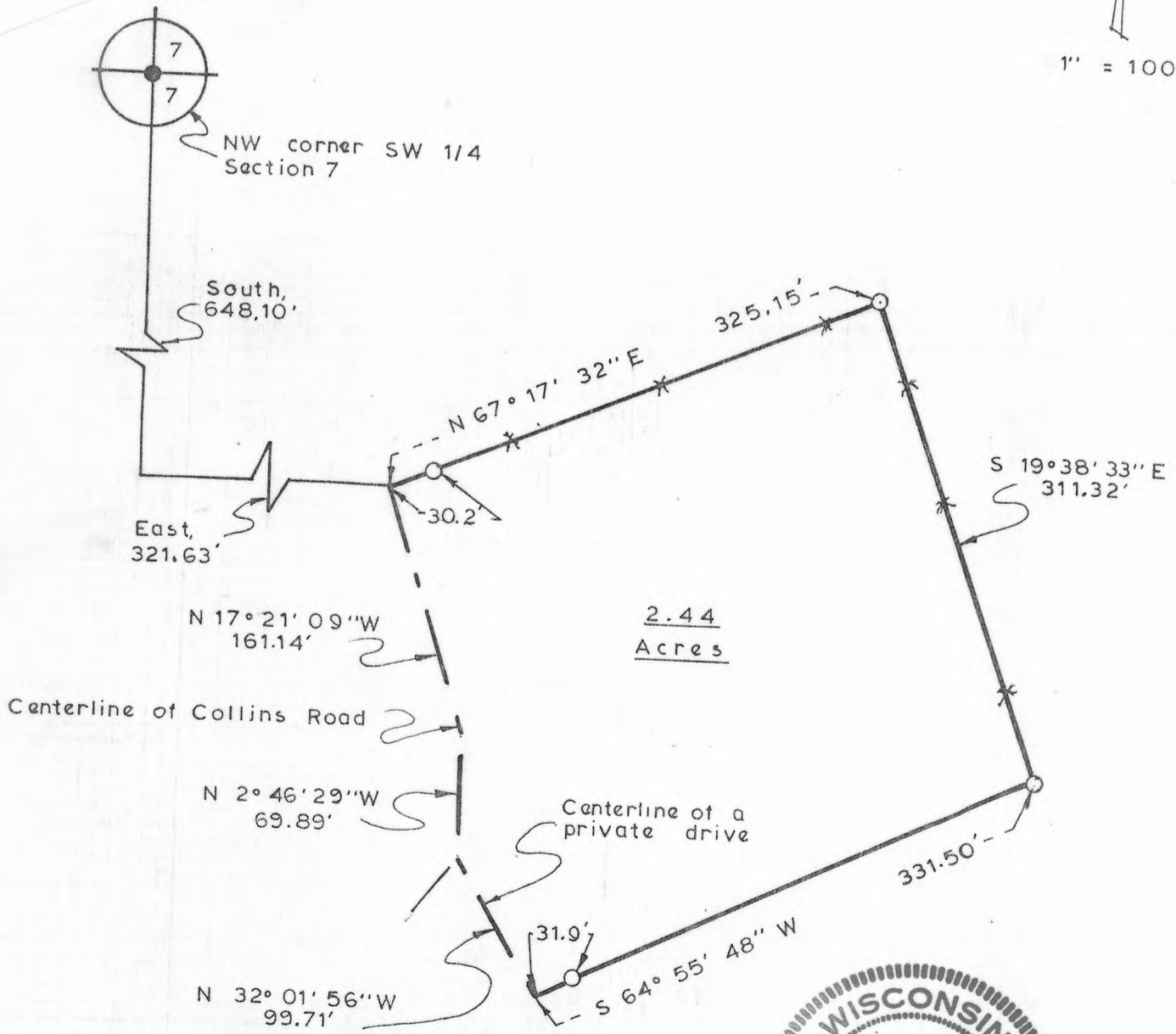
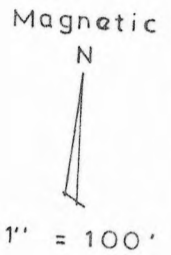
