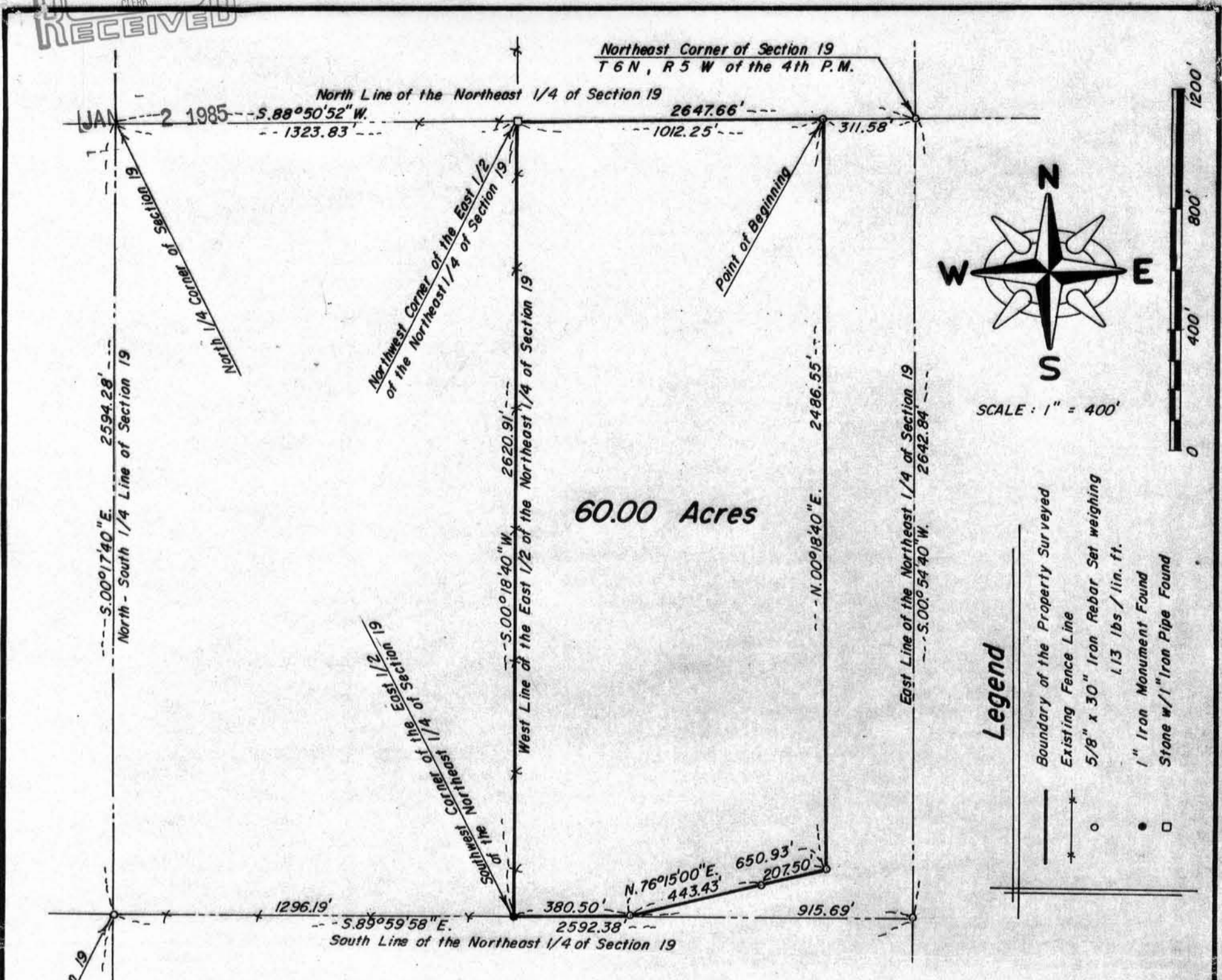

A TRACT OF LAND LOCATED IN A PART OF THE EAST 1/2 OF THE NORTHEAST 1/4 OF SECTION 19, TOWNSHIP 6 NORTH, RANGE 5 WEST OF THE FOURTH PRINCIPAL MERIDIAN, PATCH GROVE TOWNSHIP, GRANT COUNTY, WISCONSIN, THE BOUNDARY OF WHICH IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF THE NORTHEAST 1/4 OF SECTION 19, TOWNSHIP 6 NORTH, RANGE 5 WEST OF THE FOURTH PRINCIPAL MERIDIAN; THENCE S. 88° 50' 52" W., ALONG THE NORTH LINE OF THE NORTHEAST 1/4 OF SAID SECTION 19, A DISTANCE OF 311.58 FEET TO THE POINT OF BEGINNING OF THE FOLLOWING DESCRIBED TRACT; THENCE CONTINUING S. 88° 50' 52" W., ALONG SAID NORTH LINE, A DISTANCE OF 1012.25 FEET TO THE NORTHWEST CORNER OF THE EAST 1/2 OF THE NORTHEAST 1/4 OF SAID SECTION 19; THENCE S. 00° 18' 40" W., ALONG THE WEST LINE OF THE EAST 1/2 OF THE NORTHEAST 1/4 OF SAID SECTION 19, A DISTANCE OF 2620.91 FEET TO THE SOUTHWEST CORNER OF THE EAST 1/2 OF THE NORTHEAST 1/4 OF SAID SECTION 19; THENCE S. 89° 59' 58" E., ALONG THE SOUTH LINE OF THE NORTHEAST 1/4 OF SAID SECTION 19, A DISTANCE OF 380.50 FEET; THENCE N. 76° 15' 00" E., 650.93 FEET; THENCE N. 00° 18' 40" E., 2486.55 FEET TO THE POINT OF BEGINNING, SAID TRACT CONTAINING 60.00 ACRES, MORE OR LESS, SUBJECT TO ANY AND ALL RECORDED EASEMENTS AND RIGHT-OF-WAYS, ALL SITUATED IN GRANT COUNTY, WISCONSIN.
