

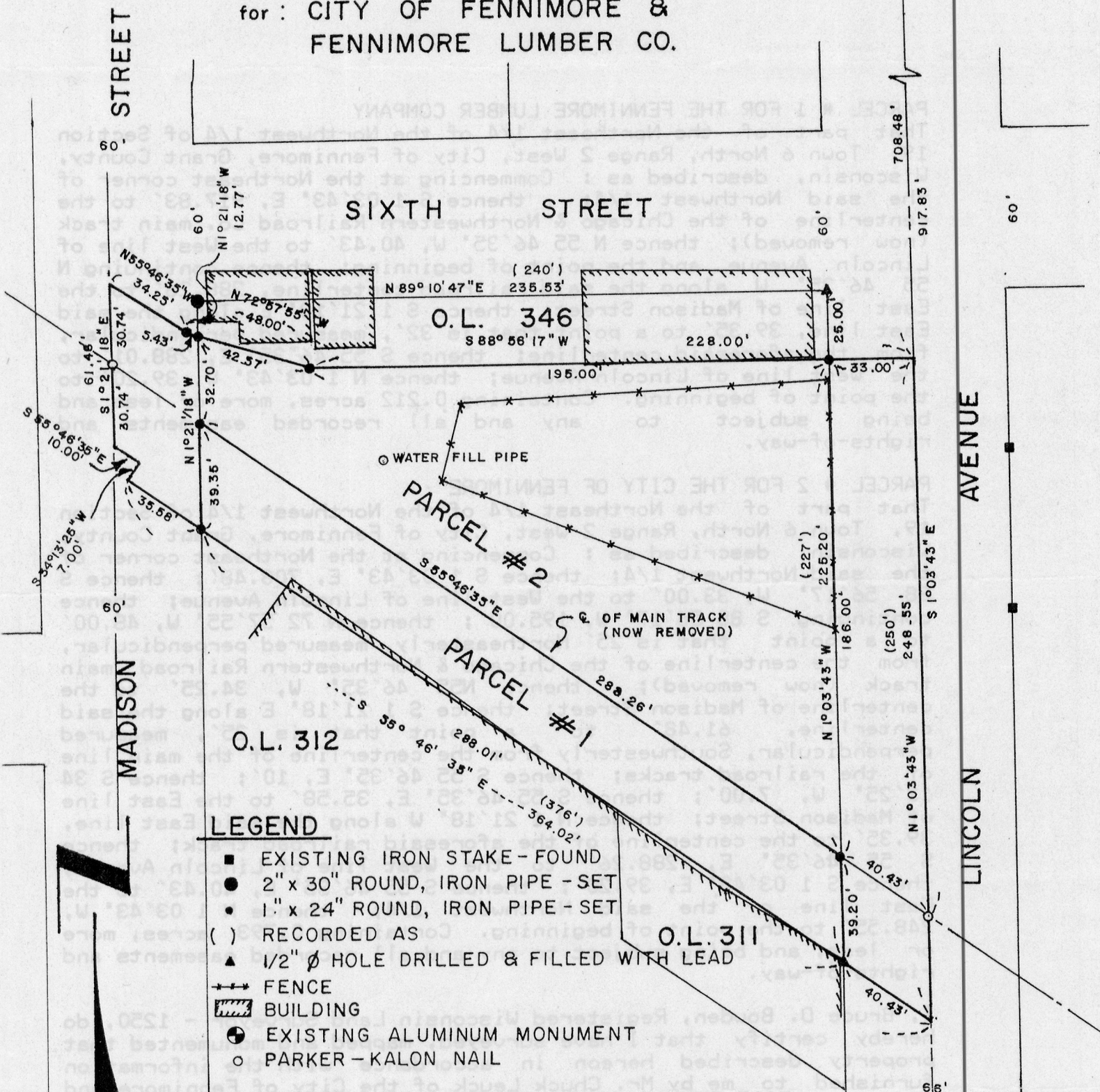

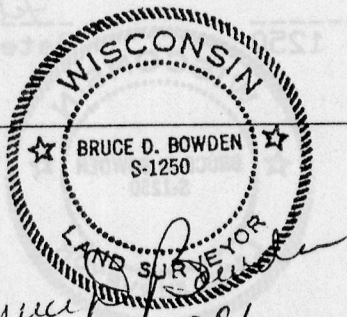
NORTHEAST CORNER OF THE NORTHWEST 1/4.

PARCEL # 1 FOR THE FENNIMORE LUMBER COMPANY  
 That part of the Northeast 1/4 of the Northwest 1/4 of Section 19, Town 6 North, Range 2 West, City of Fennimore, Grant County, Wisconsin, described as: Commencing at the Northeast corner of the said Northwest 1/4; thence S 1 03'43" E, 917.83' to the centerline of the Chicago & Northwestern Railroad Co. main track (now removed); thence N 55 46'35" W, 40.43' to the West line of Lincoln Avenue and the point of beginning; thence continuing N 55 46'35" W along the said railroad centerline, 288.26' to the East line of Madison Street; thence S 1 21'18" E along the said East line, 39.35' to a point that is 32', measured perpendicular, from the aforesaid centerline; thence S 55 46'35" E, 288.01' to the West line of Lincoln Avenue; thence N 1 03'43" W, 39.20' to the point of beginning. Containing 0.212 acres, more or less and being subject to any and all recorded easements and rights-of-way.

 That part of the Northeast 1/4 of the Northwest 1/4 of Section 19, Town 6 North, Range 2 West, City of Fennimore, Grant County, Wisconsin, described as: Commencing at the Northeast corner of the said Northwest 1/4; thence S 1 03'43" E, 708.48'; thence S 88 56'17" W, 33.00' to the West line of Lincoln Avenue; thence continuing S 88 56'17" W, 195.00'; thence N 72 57'55" W, 48.00' to a point that is 25' Northeasterly, measured perpendicular, from the centerline of the Chicago & Northwestern Railroad main track (now removed); thence N55 46'35" W, 34.25' to the centerline of Madison Street; thence S 1 21'18" E along the said centerline, 61.48' to a point that is 25', measured perpendicular, Southwesterly from the centerline of the main line of the railroad tracks; thence S 55 46'35" E, 10'; thence S 34 13'25" W, 7.00'; thence S 55 46'35" E, 35.58' to the East line of Madison Street; thence N 1 21'18" W along the said East line, 39.35' to the centerline of the aforesaid railroad track; thence S 55 46'35" E, 288.26' to the West line of Lincoln Avenue; thence S 1 03'43" E, 39.20'; thence S 55 46'35" E, 40.43' to the East line of the said Northwest 1/4; thence N 1 03'43" W, 248.55' to the point of beginning. Containing 0.793 acres, more or less, and being subject to any and all recorded easements and rights-of-way.
