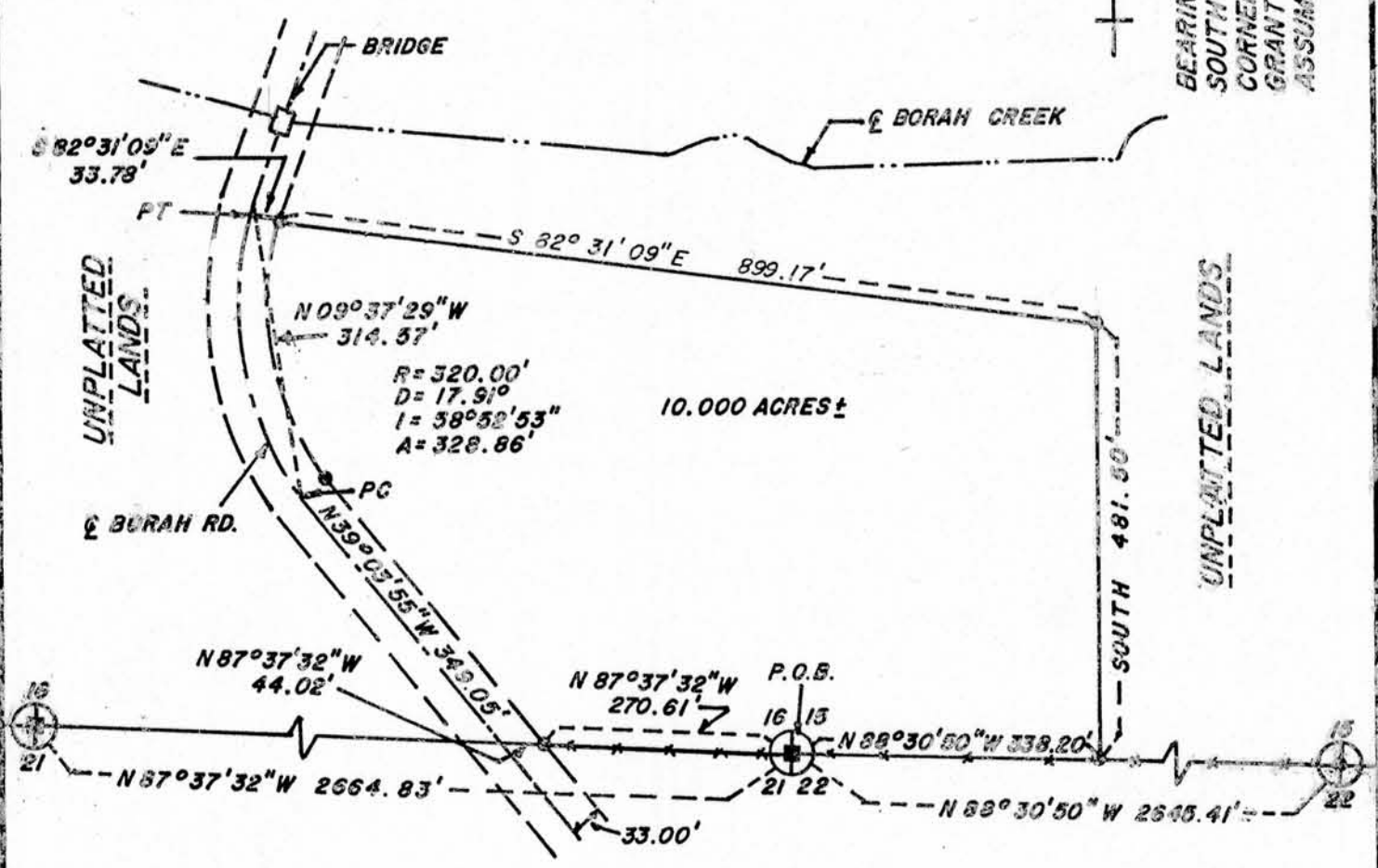

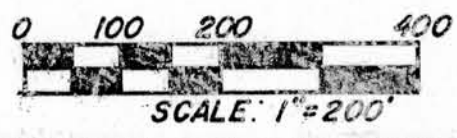

A parcel of land located in the SW 1/4 of the SW 1/4 of Section 15 and the SE 1/4 of the SE 1/4 of Section 16, all in T5N, R3W, North Lancaster Township, Grant County, Wisconsin, described as follows:

Commencing at a 1" iron bar marking the southwest corner of said Section 15 and also being the point of beginning; thence N 87° 37' 32" W 270.61' along the south line of said Section 16 to a 1" iron pipe; thence N 87° 37' 32" W 44.02' to the center of Borah Road; thence N 39° 03' 55" W 349.05' along the centerline of said road to the beginning of a 320.00' radius curve to the right; thence northeasterly 328.86' along the arc of said curve, making a central angle of 58° 52' 53" and a long cord of 314.57' that bears N 9° 37' 29" W; thence S 82° 31' 09" E 33.78' to a 1" iron pipe; thence S 82° 31' 09" E, 899.17' to a 1" iron pipe; thence south 481.50' to a 1" iron pipe located on the southern line of the SW 1/4 of said Section 15; thence N 88° 30' 50" W 338.20' along the southern line of the SW 1/4 of said Section 15 to the point of beginning.


