Commencing at the Northeast corner of the said Southeast 1/4; thence S 0° 28' 25" W, 330.00'; thence S 89° 52' 25" W, 325.00'; to the point of beginning; thence N 0° 28' 25" E, 520.00'; thence S 89° 52' 25" W, 420.00'; thence S 0° 28' 25" W, 520.00'; thence N 89° 52' 25" E, 420.00' to the point of beginning. Containing 5.01 acres, more or less, and being subject to any and all recorded easements and rights-of-way.

Together with a two rod easement for ingress and egress over and above that part of the East 1/2 of the East 1/2 of the Southeast 1/4 of Section 3, Town 6 North, Range 3 West, Mount Ida Township, Grant County, Wisconsin, the center line of which is more fully described as:

Commencing at the Northeast corner of the said Southeast corner; thence S 0° 28' 25" W along the East line thereof, 330.00'; thence S 89° 52' 25" W, 284.50' to the point of beginning of the line being described; thence S 2° 21' 55" W, 285.06'; thence S 14° 58' 20" W, 356.47'; thence S 4° 37' 55" W, 531.16'; thence S 27° 15' 55" W, 118.92' to the center line of Green River Road and the termination of the line being described.
